Mr. Chair, it is true the Provincial Legal Office opined that the same should be reviewed to make sure that it is compliant with Section 336 of RA 7160 which states that, "no ordinance shall be passed authorizing any transfer of appropriations from one item to another".

Mr. Chair, it appears that, with due respect to the Provincial Legal Office, it 955 appears that the same is being interpreted in Section 336. Actually, what is prohibited 956 957 under the Local Government Code is transfer of funds from one expense class to another. For instance, from MOOE to Salaries and Wages, that is not allowed. But 958 within the same expense class it can be allowed by legislative ordinance as in this case, 959 Mr. Chair. That is why by the wording "realigned" or "transfer" it does not violate Section 960 336. And to request a review of the same would be superfluous considering that there 961 are so many disasters happening which is why, perhaps, I'm not privy to the discussions 962 in the Sangguniang Bayan of Mahaplag. But instead of buying an emergency service 963 vehicle they opted to buy many backhoe. Instead of buying food assistance they opted 964 to buy a generator with light power. And I think these proceeds from their experience, 965 during the landslides and many disasters, the earthquakes that is going on, that has 966 happened in Mahaplag during Typhoon Agaton, Mr. Chair. 967

On that note, Mr. Chair, I reiterate my second to the motion of Honorable Carmen Cari, that we approve this with due respect and without regard to the opinion of the Provincial Legal Office. I so move, Mr. Chair. I would like to state on record.

For instance, when everybody is told to evacuate, they would not evacuate if they cannot provide for their daily subsistence so that is why the government provides food. But of course, yes, it is allowed. We have no law or issuance that disallows the use of pre disaster preparedness fund for some other uses. Instead of buying food, they can buy a backhoe in this case or a generator which will be even more relevant to the happening of calamities in LGUs like Mahaplag. I hope it is to the satisfaction of the former Mayor of Carigara.

Because, Mr. Chair, I understand that the Calamity Fund is 5%.

1031 Yes, it is 70% of the 5%. It is not really different funds.

1033 Only 70% of the 5%, because 5% is only allowed by law.

So that is why, I see that there is no problem in the realignment. We just say realignment because it's from one item to another item, different products. Instead by 4x4 vehicles they purchased the backhoe. But there's no such thing as they juggle the funds, from one item to the other nomenclature, Mr. Chair.
