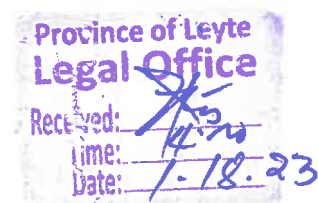

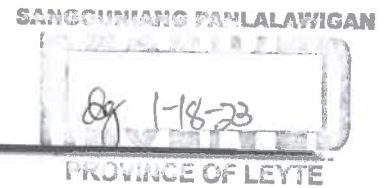

**MUNICIPAL ORDINANCE NO. 19-22-007**

**AN ORDINANCE ADOPTING AN OFFICIAL MUNICIPAL HYMN OF THE MUNICIPALITY OF ISABEL, LEYTE.**

**WHEREAS**, submitted for the body's official adoption is the Isabel Municipal Hymn entitled "*Lungsod nga Matahom*";

**WHEREAS**, "*Lungsod nga Matahom*" has been composed to best describe Isabel, its past and current situations, as well as its people's aspirations as a progressive, safe, and peaceful municipality;

**WHEREAS**, serving as an inspiration to the people of Isabel, Leyte, the Sangguniang Bayan of Isabel deemed it proper to adopt "*Lungsod nga Matahom*" as the official Municipal Hymn;

**WHEREFORE**, on motion of SB Member Deborah G. Bertulfo, unanimously seconded by all members present, be it:

**ORDAINED**, by the Sangguniang Bayan of Isabel, Leyte, in a regular session assembled, that:

**SECTION 1. TITLE** – This Ordinance shall be known as the "ISABEL MUNICIPAL HYMN".

Section 2. There shall be adopted a composition entitled "*Lungsod nga Matahom*" as the official Municipal Hymn of Isabel, Leyte. The song shall become the property of the municipality which composition shall form part of this Ordinance:


