AN ORDINANCE CREATING A NEW PLANTILLA POSITION IN THE GENERAL SERVICES OFFICE OF THE MUNICIPAL GOVERNMENT OF TABANGO, LEYTE, PROVIDING FOR ITS QUALIFICATIONS, DUTIES, AND FUNCTIONS AND APPROPRIATING THE NECESSARY FUNDS THEREOF.

Be it enacted by the Sangguniang Bayan of Tabango, Leyte in session assembled that:

SECTION 1. CREATION AND QUALIFICATION STANDARDS - The following plantilla position is hereby created with its respective salary grade, and qualification standards, to wit:

GENERAL SERVICES OFFICE

- 1) Supply Officer III
Salary Grade: 18
Education: Bachelor's Degree
Experience: 2 years relevant experience
Training: 8 hours of relevant training
Eligibility: Career Service Professional, Second Level Eligibility
No. of Personnel (Item): 1

SECTION 2. DUTIES AND FUNCTIONS. The duties and functions of the above-stated positions shall be based on the provisions of the Local Government Code of 1991, the Civil Services Commission (CSC), and other relevant laws, rules, and regulations.

SECTION 3. FUNDING. The newly created positions are made an integral part of the Plantilla of Positions of the Local Government Unit of Tabango and shall be funded accordingly.


SECTION 4. SEPARABILITY CLAUSE. If for any reason, any part or provision of this Ordinance shall be found to be unconstitutional or invalid, other parts or provisions thereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.






