MUNICIPAL ORDINANCE NO. 22-006

AN ORDINANCE CREATING THE POSITIONS OF DENTIST I WITH SALARY GRADE 14 AND PHARMACIST I WITH SALARY GRADE 11 UNDER THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPAL LOCAL GOVERNMENT OF MAHAPLAG, LEYTE

BE IT ENACTED, as it is hereby enacted, by the Sangguniang Bayan of Mahaplag, Leyte, in session assembled:

Section 1. This is pursuant to the pertinent provisions of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, primarily Section 447 paragraph (a) subparagraph (1) with subparagraphs (vii) and (viii), pertaining to the powers of the Sangguniang Bayan to determine the powers, duties, positions and salaries of employees of the municipality, and Section 81 on the Sangguniang Bayan's power to determine the compensation of personnel in the Municipal Local Government of Mahaplag, Leyte.

Section 2. The position of Dentist I with Salary Grade 14 is hereby created under the Municipal Health Office of the Municipal Local Government of Mahaplag, Leyte.

Section 3. The position of Pharmacist I with Salary Grade 11 is hereby created under the Municipal Health Office of the Municipal Local Government of Mahaplag, Leyte.

















- SEPARABILITY CLAUSE. If, for any reason, any item, section or provision of this Ordinance is declared invalid or unconstitutional, the other items, sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.
- **REPEALING CLAUSE**. All ordinances, resolutions or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.
- Section 6. EFFECTIVITY CLAUSE. This Ordinance shall be effective immediately upon approval by the Local Chief Executive.
