CONSIDERING the foregoing facts, this AUGUST BODY hereby expresses for the granting of FRANCHISE to MR. FRANCIS ANGELO A. ROA on the authority of section 447., parag., 3, sub parag., (v) of RA 7160, otherwise known as the Local Government Code of 1991, which provides that "ANY LAW TO THE CONTRARY NOTWITHSTANDING AUTHORIZE AND LICENSE THE ESTABLISHMENT, OPERATION AND MAINTENACE OF COCKPIT AND REGULATE COCKFIGHTING AND COMMERCIAL BREEDING OF MECOCKS, provided, "That existing rights should not be prejudiced." In relation to section 444., parag 3. sub para (iv) which provides that "THE MUNICIPAL MAYOR SHALL xxx issue license and permits and spend or revoke the same for any violation of the conditions upon which the said license or permits had been issued, pursuant to law on ordinance".

FOREGOING premises considered, it is earnestly recommended that the hereby ordinance be hacted.

Be it Ordained by the SANGGUNIANG BAYAN, municipality of TOLOSA, LEYTE.

SECTION 1. A franchise is hereby granted to MR. FRANCIS ANGELO A. ROA to operate and maintain cockpit and amusement center at BARANGAY CANTARIWIS, TOLOSA, LEYTE, under the following conditions:

- This franchise shall be for a period of **TWENTY FIVE (25) years**, commencing from the effectivity of this ordinance, however, after twenty five years thereof, the Franchisee shall renew the franchise for a period of every five (5) years thereafter, and subject to the approval of the SANGGUNIAN BAYAN.
- The Grantee shall adhere to the municipal business tax and/or such other taxes levied upon the local tax code and municipal ordinance.
- 3. The Franchisee shall pay the Franchise in the amount of P15,000.00 as cockpit regulatory fee, payable within one (1) year, on equal quarterly payment upon the approval of this ordinance.
- The Franchisee shall also pay all the regulatory fees to the Municipal Treasurer or his representative.
- That the herein FRANCHISE is non-transferrable.
- That the proper maintenance and sanitation shall strictly be observed by the Grantee.
- That the Grantee shall strictly observed the provisions of Ordinance No. 05 series of 1996, otherwise known as "An Ordinance Regulating the establishment, Operation and Maintenance, of cockpits, cockfighting and commercial breeding of gamecock in the town of Tolosa, Leyte", and other related laws and ordinances;
- 8. The Grantee after the approval of the FRANCHISE shall comply with the following, to wit;
 - a.) The establishment shall provide a septic tank for the sewerage disposal and sanitary toilet and parking space.
 - b.) The setback requirements from the edge of the road right of way.
 - c.) Provision of the NATIONAL BUILDING CODE.
 - d.) Secure Certificate of Non-Coverage from the DENR and Locational Clearance/Zoning permit from the office of the municipal Planning and Development Coordinator.
 - e.) Strict compliance of the provision of the HOUSING AND LAND USE REGULATORY BOARD, specifically on the design Standard and Guidelines for COCKPIT.

SECTION 2. The Municipality of Tolosa is hereby empowered to issue a MAYOR'S PERMIT for the operation and maintenance of the cockpit upon issuance of the Franchise and compliance of all the requirements as provided in section 1 of this Ordinance.

Barangay Council of Barangay CANTARIWIS, TOLOSA, LEYTE on June 15, 2022 Adopted Sanggunian Barangay Resolution No. 55 favorably expressing NO OBJECTION, likewise, ENDORSING FRANCIS ANGELO A. ROA to operate a cockpit and amusement center located at Barangay CANTARIWIS, FOLOSA, LEYTE.

MR. FRANCIS ANGELO A. ROA of Barangay Quilao, Tolosa, Leyle personally appeared to the angguniang Bayan of this Municipality and religiously submitted all the necessary documents relative to his quest, his application for a FRANCHISE TO OPERATE AND MAINTAIN A COCKPIT AND AMUSEMENT CENTER in Barangay Cantariwis, Tolosa, Leyte.

Based on records maintained by the office of the SANGGUNIANG BAYAN of TOLOSA, LEYTE howed, that said office have not issued any FRANCHISE to anybody, until the herein applicant applied for the purpose.

The Local Chief Executive favorably endorsed Mr. Francis Angelo A. Roa based on the documents presented.

CONSIDERING the foregoing facts, this AUGUST BODY hereby expresses for the granting of RRANCHISE to MR, FRANCIS ANGELO A. ROA on the authority of section 447., parag., 3, sub parag., (v) of RA 7160, otherwise known as the Local Government Code of 1991, which provides that "ANY LAW TO THE CONTRARY NOTWITHSTANDING AUTHORIZE AND LICENSE THE ESTABLISHMENT, OPERATION AND MAINTENACE OF COCKPIT AND REGULATE COCKFIGHTING AND COMMERCIAL BREEDING OF GAMECOCKS, provided, "That existing rights should not be prejudiced." In relation to section 444., parag 3., sub para (iv) which provides that "THE MUNICIPAL MAYOR SHALL xxx issue license and permits and suspend or revoke the same for any violation of the conditions upon which the said license or permits had been issued, pursuant to law on ordinance".

FOREGOING premises considered, it is earnestly recommended that the hereby ordinance be enacted.

Be it Ordained by the SANGGUNIANG BAYAN, municipality of TOLOSA, LEYTE.

SECTION 1. A franchise is hereby granted to MR. FRANCIS ANGELO A. ROA to operate and maintain a cockpit and amusement center at BARANGAY CANTARIWIS, TOLOSA, LEYTE, under the following conditions:

- 1. This franchise shall be for a period of TWENTY FIVE (25) years, commencing from the effectivity of this ordinance, however, after twenty five years thereof, the Franchisee shall renew the franchise for a period of every five (5) years thereafter, and subject to the approval of the SANGGUNIAN
- The Grantee shall adhere to the municipal business tax and/or such other taxes levied upon the local lax code and municipal ordinance.
- The Franchisee shall pay the Franchise in the amount of P15,000.00 as cockpit regulatory fee, payable within one (1) year, on equal quarterly payment upon the approval of this ordinance.
- The Franchisee shall also pay all the regulatory fees to the Municipal Treasurer or his representative.
- That the herein FRANCHISE is non-transferrable.
- That the proper maintenance and sanitation shall strictly be observed by the Grantee.
- That the Grantee shall strictly observed the provisions of Ordinance No. 05 series of 1996, otherwise known as "An Ordinance Regulating the establishment, Operation and Maintenance, of cockpits, cocklighting and commercial breeding of gamecock in the town of Tolosa, Leyte", and other related laws and ordinances:
- The Grantee after the approval of the FRANCHISE shall comply with the following, to wit;

- a.) The establishment shall provide a septic tank for the sewerage disposal and sanitary toilet and parking space.
- b.) The setback requirements from the edge of the road right of way.
- c.) Provision of the NATIONAL BUILDING CODE.
- d.) Secure Certificate of Non-Coverage from the DENR and Locational Clearance/Zoning permit from the office of the municipal Planning and Development Coordinator.
- e.) Strict compliance of the provision of the HOUSING AND LAND USE REGULATORY BOARD specifically on the design Standard and Guidelines for COCKPTT.

SECTION 2. The Municipality of Tolosa is hereby empowered to issue a MAYOR'S PERMIT for the operation and maintenance of the cockpit upon issuance of the Franchise and compliance of all the requirements as arbyided in section 1 of this Ordinance.

SECTION 3. The Franchisee whenever a special permit to hold a DERBY and PINTAKASI is secured and issued by the Municipal Mayor and concurred by the SANGGUNIAN BAYAN, the holding of the DERBY shall be held at their cockpit.

SECTION 4. In case of violation by the Franchisee of the terms and conditions and/or requirements provided herein and the pertinent laws, rules, and regulations, as well as the Laws, Ordinance that may Thereinafter, be promulgated, the Municipality of Tolosa thru the SANGGUNIAN BAYAN, have the right to withdraw or suspend the FRANCHISE.

SECTION 5. This Ordinance shall take effect in accordance with the provision of the Local Government Code.
