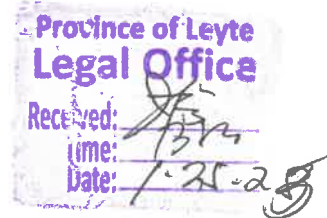

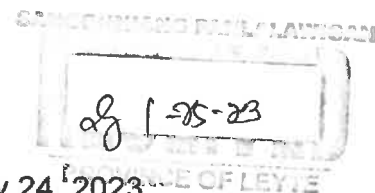

SECTION 1. TITLE – This Ordinance shall be known as fare rates for Tricycles and Pedicabs of the Municipality of Alangalang.

- b. Twenty percent (20%) discount on the actual fare shall be granted to Persons with Disabilities pursuant to Republic Act No. 9224 otherwise known as "An Act Amending the Magna Carta for Disabled Persons and for Other Purposes".
- c. Twenty percent (20%) discount on the actual fare shall be granted to students pursuant to LTFRB Memorandum Circular No. 2017-024 dated 11 October, 2017.

1. For Senior Citizens/PWD/STUDENT

- d. Twenty percent (20%) discount on the actual fare shall be granted to Senior Citizens pursuant to Republic Act 994 otherwise known as the "Expanded Senior Citizens Act of 2010".
- e. Twenty percent (20%) discount on the actual fare shall be granted to Persons with Disabilities pursuant to Republic Act No. 9442 otherwise known as "An Act Amending the Magna Carta for Disabled Persons and For Other Purposes".
- f. Twenty percent (20%) discount on the fare shall be granted to students pursuant to LTFRB Memorandum Circular No. 2017-024 dated 11 October, 2017.

SECTION 3. REQUIREMENT TO AVAIL OF THE DISCOUNT PROVIDED FOR UNDER (2) SECTION 2.

Senior Citizens, Persons with Disabilities, Students shall present their respective valid identification Cards to avail of such discount.

SECTION 4. PROPER POSTING OF THE NEW FARE RATES.

All tricycle and pedicab for hire in the municipality of Alangalang shall post the new Tricycle and Pedicab Fare Matrix within the passenger's view upon the implementation of this ordinance.

SECTION 5. REGULATORY FEE

All tricycle and pedicab operators/drivers shall pay the minimum amount of Fifteen (15.00) pesos to the Municipal Treasurers Office before the BPLO office releases the Fare Matrix to the operators/drivers.

SECTION 6. MANDATORY IMPOSITION OF FARE RATES.

The new fare rate provided under Section 2 hereof, shall be strictly imposed regardless of whether the tricycle is queuing or carrying only one passenger.

SECTION 7. SEPARABILITY CLAUSE.

Should any provision herein declared unconstitutional or invalid by a court of competent jurisdiction, the same shall does not affect the validity of the other provisions of this ordinance.

SECTION 8. REPEALING CLAUSE.

All Ordinances inconsistent with this ordinance are hereby amended, repealed or modified accordingly.

SECTION 9. EFFECTIVITY.

This Ordinance shall take effect upon approval and compliance with the applicable statutory provisions.


