

A RESOLUTION TO APPROVE THE MUNICIPAL ORDINANCE NO. 01 S2023 ENTITLED "AN ORDINANCE AMENDING SECTION 3A.03 OF MUNICIPAL ORDINANCE NO. 01 SERIES OF 2018 OTHERWISE KNOWN AS THE MUNICIPAL REVENUE CODE OF TABONTABON, LEYTE AS AMENDED FOR THE PURPOSE OF EXTENDING THE DEADLINE FOR THE PAYMENT OF BUSINESS PERMIT FEES, TAXES AND/OR CHARGES AND RENEWAL OF BUSINESS PERMITS FOR THE CALENDAR YEAR 2023 IN THE MUNICIPALITY OF TABONTABON WITHOUT SURCHARGES AND/OR PENALTIES UNTIL FEBRUARY 20, 2023".

WHEREAS, Section 3A.03 of Municipal Ordinance No. 001 Series of 2018 otherwise known as "The Municipal Revenue Code of Tabontabon, Leyte" expressly provide that the payment of business permit fees and the renewal of business permit shall be paid and renewed, respectively on or before the twentieth (20th) day of January of each year;

WHEREAS, Section 167 of the 1991 Local Government Code provides that "all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case maybe. The sanggunian concerned may, for justifiable reason or cause, extend the time of payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months";

WHEREAS, Section 168 of the same Code, provides that "The sanggunian may impose a surcharge not exceeding twenty five percent (25%) of the amount of taxes, fees or charges not paid on time and an interest at the rate not exceeding two percent (2%) per month of the unpaid taxes, fees or charges including surcharges, until such amount is fully paid but in no case shall the total interest on the unpaid amount or portion thereof exceed thirty fix 6) months";
