- Household consumption and nutrition (availability of fresh eggs and fresh vehetables)

3. Key Recommendations

- Continued cooperation among farmers
- Farmers can also be trained to grow/save seeds for the subsequent season
- Creating awareness to beneficiaries on selling harvests in the nearby market for sale
