WHEREAS, by tradition and long practice, every Sunday of the week has been the designated regular market day for the Municipality of Barugo;

WHEREAS, the public market plays a vital role in the development of the local economy and provides a venue for ambulant vendors and helps indigent constituents sell their farm products and earn a decent living;

WHEREAS, market days are proven to be of great help in generating additional income for the municipality and its constituents; and

WHEREAS, designating an additional day as a regular market day would be advantageous to the local economy and convenient for the community.

NOW, THEREFORE, On Motion of Hon. Jesus B. Cabanacan duly seconded by Hon. Nikkos Rhet Astorga, resolve, as it is hereby resolved, to pass this resolution approving the Third and Final Reading of the Ordinance Designating every Saturday and Sunday as the Regular Market Days for the Municipality of Barugo, Leyte.

**ORDINANCE NO. 05, s. of 2022**

**AN ORDINANCE DESIGNATING EVERY SATURDAY AND EVERY SUNDAY AS THE REGULAR MARKET DAYS FOR THE MUNICIPALITY OF BARUGO, LEYTE**

Be it Ordained by the Honorable members of the Sangguniang Bayan of the Municipality of Barugo, Leyte, in regular session assembled, that:

**SECTION 1. SHORT TITLE.** This Ordinance shall also be known as the "Designated Market Days Ordinance of Barugo."

**SECTION 2. PURPOSE.** This Ordinance designates regular market days for the Municipality of Barugo, Leyte and adds another day as a regular market day.

**SECTION 3. STATEMENT OF POLICY.** The Municipality of Barugo strongly supports and encourages programs that sustain the livelihood and improve the local economy. It is firm in its commitment to ensure that initiatives yield long-lasting results for individuals and the community. Consistent with this commitment, it continually looks for ways to better serve the interest and welfare of the community.

**SECTION 4. REGULAR MARKET DAYS.** Every Saturday and every Sunday of the week are hereby designated as regular market days for the Municipality of Barugo, Leyte.

**SECTION 5. COORDINATION.** The Municipal Market Supervisor shall inform local vendors and ambulant vendors of the designation of Saturday as the second regular market day and encourage their participation.

**SECTION 6. REPEALING CLAUSE.** All ordinances, rules and regulations, or parts thereof, inconsistent or in conflict with the provisions of this ordinance, shall be deemed repealed or amended accordingly.


**SECTION 13. SEPARABILITY CLAUSE.** Should any provision of this ordinance be declared by a court of competent jurisdiction to be illegal, unconstitutional or invalid the other provisions not so affected shall remain valid and effective.


**SECTION 14: EFFECTIVITY.** This ordinance shall take effect upon its approval.
