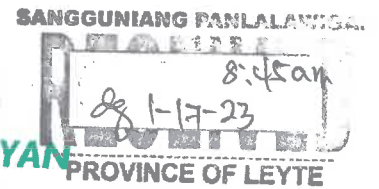

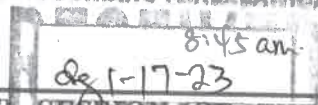

A RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 12, SERIES OF 2022 "AN ORDINANCE CREATING THE PLANTILLA POSITIONS OF ACCOUNTANT III (SG 19) IN THE MUNICIPAL ACCOUNTING OFFICE AND ENGINEER II (SG 16) IN THE MUNICIPAL ENGINEERING OFFICE OF THE LOCAL GOVERNMENT UNIT OF MERIDA, PROVINCE OF LEYTE."

NOW, WHEREFORE, ON MOTION OF Hon. Nenfa C. Oyao, Chairman Committee on Business, Trade, Industry, Consumer Protection, Labor and Employment, duly seconded by MASS, BE IT RESOLVED TO ENACT;

A RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 12, SERIES OF 2022 "AN ORDINANCE CREATING THE PLANTILLA POSITIONS OF ACCOUNTANT III (SG 19) IN THE MUNICIPAL ACCOUNTING OFFICE AND ENGINEER II (SG 16) IN THE MUNICIPAL ENGINEERING OFFICE OF THE LOCAL GOVERNMENT UNIT OF MERIDA, PROVINCE OF LEYTE."

Be it Ordained by the Sangguniang Bayan (18th Council) of Merida, Leyte on its Regular Session assembled and by Authority of the same that;

SECTION 1. Creation of Additional Plantilla Positions is within the Authority and power vested upon the Local Government Unit in consonance with the provisions of the Local Government Code of 1991 (RA 7160);

SECTION 2. The Creation of Accountant II (SG19) in the Municipal Accounting Office and Engineer II (SG 16) in the Municipal Engineering Office are designed to complement the staffing needs subject to pertinent policies of the Civil Service Commission (CSC), Department of Budget and Management (DBM), and the Commission on Audit (COA);

SECTION 3. The Executive Department, through the Human Resource and Management Office (HRMO) is authorized to effect the newly created Plantilla of Positions of the Local Government Unit of Merida, Leyte;

SECTION 4. This Municipal Ordinance shall take effect upon its approval by the Sangguniang Panlalawigan ng Leyte and compliance of the posting requirements as provided for in the Local government Code of 1990 (RA No. 7160).




