assembled, that:

Section 1. Seal Symbolism. The Municipal Disaster Risk
Reduction Management Office Logo of Matag-ob, Leyte shall be

MUNICIPAL IMAGE

: Image of the town of Matag-ob as depicted in the official seal of the Municipality with 21 rays representing the 21 barangays comprising the municipality, and the two (2) natig-ob rivers where the name of the town originated.

SUN RAYS

: Representing the 21 barangays comprising the Municipality of Matag-ob

LIFEBUOY

: The orange lifebuoy represent the MDRRMO's goal to protect the town at all cost

ROPES

: Wrapped around are ropes representing "Strength in Unity" of the Office, the MDRRMO, the Rescue Unit, and the people of Matag-ob.

Section 2. Purpose and Authorized Use of Logo. The official logo of the Municipal Disaster Risk Reduction and Management Office (MDRRMO) of Matag-ob, Leyte shall be for official purpose only. It shall appear in all official documents of the MDRRMO and in circumstances where the Office permits the use thereof.

Section 3. Unauthorized use of the Logo. It shall be unlawful for any person, natural or juridical, to print the official logo of the MDRRMO for purpose of sale, distribution or circulate, manufacture, publish, use, display or offer for sale any document or items, merchandise which simulate the said official logo of the MDRRMO without the express written consent of the Local Chief Executive or the Head of its Office.

Section 4. Penalty Clause. Any violation of this provision shall be punishable by an imprisonment of not more than 30 days or a fine of not more than P2,500.00 or both, subject to the discretion of the court.

Section 5. Separability Clause. In the event that a part of this ordinance be declared invalid, the remaining provisions not declared so shall stand effective.

Section 6. Repealing Clause. Any Ordinance or measure found to be consistent with this ordinance shall be deemed repealed.

Section 7. Effectivity. This ordinance shall be effective upon its approval.


