ORDINANCE NO. 08 SERIES OF 2022

AN ORDINANCE REQUIRING ALL BARANGAYS OF THE MUNCIPALITY OF JARO, PROVINCE OF LEYTE TO ESTABLISH AND OPERATE A MATERIAL RECOVERY FACILITY (MRF).

WHEREAS, the 1987 Philippine Constitution provides that, The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature."

WHEREAS, Section 32 of Republic Act 9003 Otherwise known as Ecological Solid Waste Management Act of 2000 stipulates that, there shall be established a Materials Recovery Facility (MRF) in every barangay or cluster of barangays. The facility shall be established in a barangay owned or leased land or any suitable open space to be determined by the barangay through its Sanggunian.





For this purpose, the barangay or cluster of barangays shall allocate a certain parcel of land for the MRF. The determination of site and actual establishment of the facility shall likewise be subject to the guidelines and criteria set pursuant to this Act. The MRF shall receive mixed waste for final sorting, segregation, composting, and recycling. The resulting residual wastes shall be transferred to a long-term storage or disposal facility or sanitary landfill.

WHEREAS, Municipal Ordinance No. 07, Series of 2016 entitled "Jaro Solid Waste Management" Section 9 and Section provides that the Barangay Solid Waste Management Committee shall establish a Material Recovery Facility (MRF); ensure and kept track of its operation.

WHEREAS, aside from the laws to protect the environment it is the moral obligation of every citizen most especially the Barangay Officials to protect and nurture the environment.

WHEREAS, despite the above-mentioned laws and ordinance, most Barangays in this Municipality failed to comply.

WHEREAS, there is a need to properly establish and implement Material Recovery Facility for every Barangay, and that most Barangays in this Municipality have no proper waste management and disposal, this ordinance would supplement and enforce the aforementioned laws and municipal ordinance.

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in regular session assembled:

SECTION 1. TITLE - This Ordinance shall be known and cited as An Ordinance Requiring All Barangays of the Municipality of Jaro, Province of Leyte to Establish and Operate a Material Recovery Facility (MRF).

SECTION 2. COVERAGE - This Ordinance shall be imposed on all Barangays of this Municipality. The Public Officials responsible to implement this Ordinance are those mentioned under Section 9 of Ordinance No. 07, Series of 2022, which is the Barangay Solid Waste Committee.

SECTION 3. BUDGETARY ALLOCATION - All Barangays must provide on their annual budget a budgetary allocation to establish and maintain a Materials Recovery facility. The amount is subject to the discretion of the Barangay.

SECTION 4. PENALTIES - for failure of the Barangay Solid Waste Committee members to comply with this Ordinance shall be meted with the following penalties.

- A. First Offense One Thousand Five Hundred Pesos (Php 1,500.00) and Eight (8) Hours of Community Service
- B. Second Offense Two Thousand Pesos (Php 2,000.00) and Twenty-Four (24) Hours of Community Service
- C. Third Offense Two Thousand Five Hundred Pesos (Php 2,500.00 or Imprisonment of One (1) month to Three (3) months or both fines and imprisonment at the discretion of the court.
- D. Provided Further, that the Sangguniang Barangay Officials shall be administratively liable for none-compliance of this Ordinance.

SECTION 5. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall continue to be in full force and effect.

SECTION 6. REPEALING CLAUSE - Municipal Ordinances, Resolutions, Local Executive Orders and other administrative issuances found to be inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY CLAUSE - This Ordinance shall take effect fifteen (15) days after its posting in at least three conspicuous places in the Municipality, in compliance to RA 7160.

Honorable Francisco R. Altres inquire from Hon. Emnas pertaining to the amended/increase of the regulatory fees, on whether it is high compared from the previous Ordinance. Hon. Emnas replies that the increase is minimal which is around 0.15 centavos under Section 2.2 and P 5.00 pesos under Section 2.6, he further said that the committee is open for any amendments the Body will proposed, and he will be amenable if there are corrections/amendments which will be introduced by the SB Members.

Honorable Martin A. Que, inquire from Hon. Emnas, if the MTO is issuing a corresponding cash ticket for the payment of the market entrance fees, under section 2.6, and if the MTO has a cash ticket valued at P 1.00 peso/each.

The Chair suggest to the committee to inquire from the Municipal Treasurers Office (MTO) the amount of every cash ticket they were issuing at present, and whether it is divisible at P 5.00 or P 1.00 pesos; so that, when issuing cash tickets, it should be corresponding to the fixed amount being collected, without any change.

Honorable Leo Angelo T. Pormida, informed the Body, that he has called the MTO, and informed him that the cash tickets they were issuing at present is valued at P 5.00 pesos each.

The Chair asks further from Hon. Emnas, that the type of dealers/products for N0s. 8-11 there is no changes on the corresponding entrance fees. Hon. Emnas replies that there are no amendments for the entrance fees in N0s. 8-11;

The Chair declares that it has been resolved and duly concurred by the Body that for the entrance fees of every type of dealers/product under Section 2.6; N0s. 1-7 is at P 20.00 pesos, and under Section 2.2 rental fees for booth/stalls-commercial building is P 5.00 pesos per square meters.

Further the Chair, asks on the exemption of payment of the slaughter house fees on large cattle, and other similar animals, under chapter III, Article 3, Section 1 "Slaughter and Coral Fees" there is no amendments on the provision. Hon. Emnas replies that the provisions have not been amended.

Honorable Francisco R. Altres, inquire from Hon. Emnas, in Chapter III, Article 3, Section 1, on the impositions of coral fees of P 100.00 /day on large cattle, under par. B, and in par. C and for other similar livestock if that fee is collected for the use of the corral/or for up-keep of the livestock in the slaughter house, and there is no increase on the fees.

Honorable Julian L. Emnas, replies that the coral fees of P 100/day has not been amended, and it is imposed/ collected from the owners of the animals to be slaughtered which are deposited in the coral owned by the LGU.

*Honorable Alexander N. Salgado, speaks out and then invites the attentions of the Body on Section 4, Article 2, Chapter V, he proposed to the Body to amend the "word occupying to operating.

Honorable Martin A. Que, opines and said that the purpose of the amendment introduced by Hon. Salgado is to simplify on the word occupying to operating which for him is more understandable by the public.

Honorable Leo Angelo T. Pormida, took the floor and said that he concurs to the proposal of Hon. Salgado and suggests further to make it more concrete is to amend by inclusion to read occupying and operating, which all the Body concurs thereto.

Honorable Francisco R. Altres, inquires in Article 4, Chapter IV, pertaining to the tabo day every "Thursday, for he noticed that it did not prosper; hence, the market day of the LGU is always every Sunday/s.

The Chair, opines and inform the Body, that in the previous administration, the Sanggunian has enacted a resolution declaring "Thursday" as Tabo day. Hon. Altres, is correct to say that it has not been popular to the public, it is maybe because the local constituents were not fully informed, and same true with the vendor/s from neighboring municipalities were not aware on the Tabo day every Thursday/s.

Honorable Alexander N. Salgado, opines and said considering that the Tabo day every Thursday has not been popular to the public, suggest for the LGU to concentrate Sundays only as the Tabo Day, where the local constituents have been used to.

*Honorable Leo Angelo T. Pormida, opines and informed the Body, that during the committee meeting to review the proposed ordinance there was a proposal that some public market regulatory fees and charges is free during the Tabo Day every Thursday/s, in order to attract local vendors, and supposedly the proposal should have been included in the ordinance, but such proposal/suggestion is recorded in the minutes of the committee meeting.

The Chair opines and said that the suggestions to waived some regulatory fees during the Tabo Day every Thursday, is seemingly feasible in order to attract and encourage vendors; and as such, amendment maybe be included in the final draft of the ordinance.

Honorable Alexander N. Salgado, opines and said, that he concur to waived the certain regulatory fees and charges imposed to vendors during Thursday-Tabo day to encourage them, and he also suggests for the LGU to use media to advertised that there is a Tabo Day in Jaro every Thursday/s for the information of the local constituents and vendors from the neighboring towns and further suggests that once the Tabo day every Thursday, will be fully established, perhaps the LGU may gradually imposed the regulatory fees and charges provided for in the ordinance.

Honorable Francisco R. Altres, suggests to Hon. Emnas, to prioritized the renovation of the toilet facilities in the public market for he noticed that it is not well kept and unsanitary to use. The Chair, suggests to the committee to coordinate with the MHO-Sanitary Inspector to frequently inspect the toilet facilities in the public market. In addition, thereto, Honorable Alexander N. Salgado, suggests that the LGU should assign a permanent employee who will be in-charge in the cleaning the toilet in the public market.

Honorable Leo Angelo T. Pormida, suggest for some amendments by inclusion in the ordinance to wit:

1. xxx that there should be assigned permanent employee/Market Inspector/s in every section in the public market who will be in-charge for the orderly supervision in the operation of stalls/ booths in the public market.

Honorable Leo Angelo T. Pormida, opines and invite the attention of the Body, on Article 5, Chapter IV, which provided that the sanitary maintenance and inspections of market stalls, booth, tienda/s shall be govern by the health and sanitary order, rules and regulations which were formulated/promulgated by the DOH or by the MHO, and adopted by the Sangguniang Bayan, in accordance with R.A. NO. 856, known as 'Code on sanitations of the Philippines and R.A. 9003 known as 'Ecological Solid Waste Management Act.

Therefore, the MHO, thru its sanitary inspectors has the responsibility in the maintenance of health and sanitation in the entire premises of the Pubic Market, there is only a need for an appropriate coordination.

The Chair, said that there is a need for the committee to formulate the IRR of Ordinance No. 10, Series of 2022, immediately in order to provide the minutest details of the ordinance, specifically on health and sanitation, and to coordinate with the office and personnel concerned (MHO), for the sanitary maintenance in the public market.

Honorable Rey P. Aure, inquiries from the proponent pertaining to the stalls constructed within the perimeter of the Bagsakan area if the fees/rentals collected for the use of the stalls the rates will be in accordance to 0rdinance No. 10, Series of 2022, or it is based in a separate and existing local law.

The Chair, informed the Body, that the stalls built within the perimeter of the Bagsakan area was constructed by the LGU, and it has a corresponding area therefore the fees/rentals for its use which is collected by the MTO is based on the Revised Municipal Tax Code.

The Chair, discuss to the Body, on Section 6.2, Section 6 – exemptions on the payment of slaughter house fees, under Article 3, Chapter III, which provide that "Meat Processing outside the Slaughter House" specifically for domestic consumptions shall no longer be subject to slaughter house fees, but all other necessary regulatory fees shall likewise be imposed, (ex. slaughtered carabao, or cows and other similar large cattle/ or livestock) and asks Hon. Emnas, if the provisions has been amended. Hon. Emnas replies that the provisions have not been amended.

Honorable Francisco R. Altres, inquiries from Hon. Emnas pertaining to those operating/vending processed meat outside the public market which is purportedly known as "Meat Shops" are they being charge for the regulatory fees, and what would be the rules, regulations and procedures to be followed by the owner/operator on meat shop establishment and its operation.

Honorable Leo Angelo T. Pormida, for and in behalf of the committee replies that in Ordinance No. 12, series of 2017, "Meat Shop" operators were not allowed; however, under section 4 Article 1, Chapter VI, of Ordinance No. 10, Series of 2022, Meat Shops establishments/operations is already allowed in the Municipality of Jaro.

On Section 4, Honorable Pormida, continues provided that meat shop operations shall follows the standard requirement and proceedings, in accordance with the National Inspection Service, and other governing laws, the committee will formulate the IRR on the rules and procedures in the operations of meat shops in the LGU.

Honorable Jonell Martin A. Que, opines that during his conversation with the meat and fish vendors operating inside the public market, it is their request to regulate the illegal fish and meat vendors in the municipality and then inquire if the 2.0 kilometers radius prohibition contained in ordinance N0. 12, series of 2017, will still applies.

Honorable Leo Angelo T. Pormida, replies that in Section 3, Article 2, Chapter VI, the 2.0-kilometer radius, reckoned from the Public Market still applies, Hon. Pormida informed also the Body, there are cases that still holders in the wet market (fish/meat) were also vending meat and /or fish outside the public market, the rationale of allowing meat and fish vending beyond the 2.0 kilometers radius to give the opportunity for the barangays to establish their own "Talipapa Market."

The Chair said that the information given by Hon. Pormida is true, and considering that the committee on Market and Slaughter will conduct the public hearing on November 17, 2022 at the Public Market, suggest to the committee to fully informed the meat and fish vendors that fish and meat vending is allowed, provided it is beyond the 2.0 kilometers radius provided for in Section 3, Article 2, chapter VI of ordinance no. 10, series of 2022, in order to resolved the issues.

ORDINANCE NO. 08 SERIES OF 2022

AN ORDINANCE REQUIRING ALL BARANGAYS OF THE MUNCIPALITY OF JARO, PROVINCE OF LEYTE TO ESTABLISH AND OPERATE A MATERIAL RECOVERY FACILITY (MRF).

WHEREAS, the 1987 Philippine Constitution provides that, The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature."

WHEREAS, Section 32 of Republic Act 9003 Otherwise known as Ecological Solid Waste Management Act of 2000 stipulates that, there shall be established a Materials Recovery Facility (MRF) in every barangay or cluster of barangays. The facility shall be established in a barangay owned or leased land or any suitable open space to be determined by the barangay through its Sanggunian.

For this purpose, the barangay or cluster of barangays shall allocate a certain parcel of land for the MRF. The determination of site and actual establishment of the facility shall likewise be subject to the guidelines and criteria set pursuant to this Act. The MRF shall receive mixed waste for final sorting, segregation, composting, and recycling. The resulting residual wastes shall be transferred to a long-term storage or disposal facility or sanitary landfill.

WHEREAS, Municipal Ordinance No. 07, Series of 2016 entitled "Jaro Solid Waste Management" Section 9 and Section provides that the Barangay Solid Waste Management Committee shall establish a Material Recovery Facility (MRF); ensure and kept track of its operation.

WHEREAS, aside from the laws to protect the environment it is the moral obligation of every citizen most especially the Barangay Officials to protect and nurture the environment.

WHEREAS, despite the above-mentioned laws and ordinance, most

Barangays in this Municipality failed to comply.

WHEREAS, there is a need to properly establish and implement Material Recovery Facility for every Barangay, and that most Barangays in this Municipality have no proper waste management and disposal, this ordinance would supplement and enforce the aforementioned laws and municipal ordinance.

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in regular session assembled:

SECTION 1. TITLE - This Ordinance shall be known and cited as An Ordinance Requiring All Barangays of the Municipality of Jaro, Province of Leyte to Establish and Operate a Material Recovery Facility (MRF).

SECTION 2. COVERAGE - This Ordinance shall be imposed on all Barangays of this Municipality. The Public Officials responsible to implement this Ordinance are those mentioned under Section 9 of Ordinance No. 07, Series of 2022, which is the Barangay Solid Waste Committee.

SECTION 3. BUDGETARY ALLOCATION - All Barangays must provide on their annual budget a budgetary allocation to establish and maintain a Materials Recovery facility. The amount is subject to the discretion of the Barangay.

SECTION 4. PENALTIES - for failure of the Barangay Solid Waste Committee members to comply with this Ordinance shall be meted with the following penalties.

- A. First Offense One Thousand Five Hundred Pesos (Php 1,500.00) and Eight (8) Hours of Community Service
- B. Second Offense Two Thousand Pesos (Php 2,000.00) and Twenty-Four (24) Hours of Community Service
- C. Third Offense Two Thousand Five Hundred 2,500.00 or Imprisonment of One (1) month to Three (3) months or both fines and imprisonment at the discretion of the court.
- D. Provided Further, that the Sangguniang Barangay Officials shall be administratively liable for none-compliance of this Ordinance.

SECTION 5. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall continue to be in full force and effect.
