ORDINANCE NO. 09 SERIES OF 2022

AN ORDINANCE CONDONING FINES, PENALTIES AND SURCHARGES ON REGULATORY FEES INCURRED BY LOCAL OPERATORS AND VENDORS FOR FAILURE TO PAY ON A TIMELY MANNER THEIR BUSINESS PERMITS AND LICENSES FOR THE PERIOD COVERING THE CALENDAR YEAR 2020 TO 2022.

WHEREAS, under RA 7160 otherwise known as the Local government Code of 1991, Section 134, 142, 151 and 152 allow provinces, cities, municipalities and barangays to impose and collect taxes, fees and charges on business, occupation and practice of profession.

WHEREAS, condonation of fines and penalties on regulatory fees does not fall under Section 133 of the Local Government Code which enumerates the common limitations on the taxing powers of Local Government Units.

WHEREAS, Section 192 of the Local Government Code of 1991 (Authority to Grant Tax Exemption Privileges) stipulates that Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions, as they may deem necessary.

WHEREAS, the Sangguniang Bayan Enact Ordinances, approve resolutions and appropriation funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of RA 7160 of the Local Government Code 1991.

WHEREAS, the years 2020, 2021 and 2022 are unprecedented times wherein the whole world suffered due to the COVID-19 Pandemic. Likewise, this municipality suffered the same fate. Local businesses and operators felt the brunt of this pandemic in their livelihood. Businesses which were defined as non-essentials were forced to close due to government regulations. Others continued to operate but revenue was meager due to economic hardships brought about by the pandemic.

WHEREAS, there is a precedent approved Resolution No. 2021-254 dated March 1, 2021 "A Resolution Granting Amnesty on Rentals and It's Corresponding Surcharges for the year 2020 to all Persons Legitimately Doing Business Within the Jaro Public Market".

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in regular session assembled:

SECTION 1. TITLE - this ordinance shall be known as "An Ordinance Condoning Fines, Penalties and Surcharges on Regulatory Fees Incurred by Local Business Operators and Vendors for Failure to Pay on a Timely Manner their Business Permits and Licenses for the Period Covering the Calendar Year 2020 to 2022."

SECTION 2. COVERAGE - This Ordinance shall cover all business operators and vendors doing business within the Municipality of Jaro.

SECTION 3. LIMITATION - This ordinance shall cover only Regulatory Fees on the Renewal of Business Permits and Licenses.

SECTION 4. CREDIT ON PAYMENT OF PENALTIES - For those operators who already paid for their penalties for the FY 2020, 2021 and 2022 the amount paid shall be converted as a payment credit. This credit shall be used as a deduction on the Payment of their Business Permits and Licenses for the following Quarterly or Annual payments at the option of the payor.

SECTION 5. PENALTIES - For failure to comply the persons responsible shall be meted with administrative liability.

SECTION 6. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE - Municipal Ordinances, Resolutions, Local Executive Orders or other administrative issuances found to be inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE - This Ordinance shall take effect fifteen (15) days after its posting in at least three conspicuous places in the Municipality, in compliance to RA 7160.



ORDINANCE NO.09 SERIES OF 2022

AN ORDINANCE CONDONING FINES, PENALTIES AND SURCHARGES ON REGULATORY FEES INCURRED BY LOCAL BUSINESS OPERATORS AND VENDORS FOR FAILURE TO PAY ON A TIMELY MANNER THEIR BUSINESS PERMITS AND LICENSES FOR THE PERIOD COVERING THE CALENDAR YEAR 2020 TO 2022.

WHEREAS, under RA 7160 otherwise known as the Local government Code of 1991, Section 134, 142, 151 and 152 allow provinces, cities, municipalities and barangays to impose and collect taxes, fees and charges on business, occupation and practice of profession.

WHEREAS, condonation of fines and penalties on regulatory fees does not fall under Section 133 of the Local Government Code which enumerates the common limitations on the taxing powers of Local Government Units.

WHEREAS, Section 192 of the Local Government Code of 1991 (Authority to Grant Tax Exemption Privileges) stipulates that Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions, as they may deem necessary.

WHEREAS, the Sangguniang Bayan Enact Ordinances, approve resolutions and appropriation funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of RA 7160 of the Local Government Code 1991.

WHEREAS, the years 2020, 2021 and 2022 are unprecedented times wherein the whole world suffered due to the COVID-19 Pandemic. Likewise, this municipality suffered the same fate. Local businesses and operators felt the brunt of this pandemic in their livelihood. Businesses which were defined as non-essentials were forced to close due to government regulations. Others continued to operate but revenue was meager due to economic hardships brought about by the pandemic.

WHEREAS, there is a precedent approved Resolution No. 2021-254 dated March 1, 2021 "A Resolution Granting Amnesty on Rentals and It's Corresponding Surcharges for the year 2020 to all Persons Legitimately Doing Business Within the Jaro Public Market".

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in regular session assembled:

SECTION 1. TITLE - this ordinance shall be known as "An Ordinance Condoning Fines, Penalties and Surcharges on Regulatory Fees Incurred by Local Business Operators and Vendors for Failure to Pay on a Timely Manner their Business Permits and Licenses for the Period Covering the Calendar Year 2020 to 2022."

SECTION 2. COVERAGE - This Ordinance shall cover all business operators and vendors doing business within the Municipality of Jaro.

SECTION 3. LIMITATION - This ordinance shall cover only Regulatory Fees on the Renewal of Business Permits and Licenses.

SECTION 4. CREDIT ON PAYMENT OF PENALTIES - For those operators who already paid for their penalties for the FY 2020, 2021 and 2022 the amount paid shall be converted as a payment credit. This credit shall be used as a deduction of the Payment of their Business Permits and Licenses for the following Quarterly Annual payments at the option of the payor.

SECTION 5. PENALTIES - For failure to comply the persons responsible shall be meted with administrative liability.

SECTION 6. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE - Municipal Ordinances, Resolutions, Local Executive Orders or other administrative issuances found to be inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE - This Ordinance shall take effect fifteen (15) days after its posting in at least three conspicuous places in the Municipality, in compliance to RA 7160.


