



MUNICIPAL IMAGE

: Image of the town of Matag-ob as depicted in the official seal of the Municipality with 21 rays representing the 21 barangays comprising the municipality, and the two (2) natig-ob rivers where the name of the town originated.

SUN RAYS

: Representing the 21 barangays comprising the Municipality of Matag-ob

GOLDEN LIFEBUOY

 Representing the MDRRMC's highest standard in leadership and management.

ROPES

Wrapped around are ropes representing "Strength in Unity" of the MDRRM Council, the Rescue Unit, the Office, and the people of Matag-ob.

Section 2. Purpose and Authorized Use of Logo. The official logo of the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of Matag-ob, Leyte shall be for official purpose only. It shall appear in all official documents of the MDRRMC and in circumstances where the Council permits the use thereof.

Section 3. Unauthorized use of the Logo. It shall be unlawful for any person, natural or juridical, to print the official logo of the MDRRMC for purpose of sale, distribution or circulate, manufacture, publish, use, display or offer for sale any document or items, merchandise which simulate the said official logo of the MDRRMC without the express written consent of the Local Chief Executive or the Head of its Office.

Section 4. Penalty Clause. Any violation of this provision shall be punishable by an imprisonment of not more than 30days or a fine of not more than P2,500.00 or both, subject to the discretion of the court.

Section 5. Separability Clause. In the event that a part of this ordinance be declared invalid, the remaining provisions not declared so shall stand effective.

Section 6. Repealing Clause. Any Ordinance or measure found to be consistent with this ordinance shall be deemed repealed.
