





**WHEREAS**, the Sangguniang Bayan is empowered to adopt measures intended to protect and save young citizenry from possible harm, especially that the municipality is highly regarded as a peaceful community, with a government giving utmost importance to the promotion of the well-being of children and families to ensure their safety and protection;

**WHEREAS**, it is often observed that the group of children and young adults keep on roaming, strolling and lounging around in public places, especially at night;

**WHEREAS**, most cases of accidents, crimes and other related incidents frequently take place at night due to various compelling reasons;

**WHEREAS**, prohibiting our children from continuously dwelling on with such unpleasant pastime is one way to discipline and regulate their extra activities with their peers or company;

**WHEREAS**, the municipal government believes that a curfew imposed on minors or those under the age of eighteen (18) is logical and such move is in the best interest not only of the young constituents but of the public in general as what will be promoted is the entire community's safety and welfare;

**NOW THEREFORE**, be it enacted, as it is hereby enacted by the Sangguniang Bayan of Santa Fe, Leyte, in session assembled, by virtue of the powers vested in it by law, states that;

**SECTION 1. TITLE** - This ordinance shall be known as the "CURFEW FOR MINORS ORDINANCE".

**SECTION 2. COVERAGE** - All minors or those under the age of eighteen (18) within the territorial jurisdiction of the Municipality of Santa Fe, Leyte are covered by this ordinance.

**SECTION 3. DEFINITION OF TERMS** - The following terms and phrases, whenever used in the ordinance, shall be interpreted as defined in this section:

**(a) CURFEW HOURS** - mean the hour from 10:00 o'clock in the evening until 4:00 o'clock in the morning;

**(b) MINOR** - means a natural person below eighteen (18) years old as defined in Art. 24 of RA 6809 otherwise known as the Family Code of the Philippines;

**(c) A CHILD IN CONFLICT WITH THE LAW** - refers to a child who is alleged as or adjudged as having committed an offense under the Philippine laws;

**(d) PARENT/GUARDIAN** - means:

- 1) A person who is a natural parent, adoptive parent, or step-parent of a minor; or
- 2) A person in-charge of the custody or who is taking care of a minor; or
- 3) A person at least 18 years of age authorized by a parent or guardian to accompany a minor.

**(e) PUBLIC PLACE** - means a place located in the Municipality of Santa Fe where the general public have access, including but not limited to street, highways, sidewalks, parking lots, vacant lots, parks, office buildings, schools, shops and place of entertainments such as videoke bars and similar places or establishments.

**(f) EMERGENCY** - means an unforeseen circumstance that calls immediate attention. Covers situations like natural disasters, fire, automobile accidents, or any accident requiring immediate action to prevent serious bodily injury or loss of life.

**(g) DIVERSION PROGRAM** - refers to the program that the minor in conflict with the law has to undergo after he/she is found responsible for an offense without resulting to formal court proceedings;

**(h) INTERVENTION** - refers to a series of activities which is designed to address issues that cause the minor to commit an offense. It may take in the form of individualized treatment program which may include counselling, skills training, education and other activities that will enhance his/her psychological, emotional and psycho-social well-being;

**(i) CITATION TICKET** - refers to an official order or summon to appear before an authorized enforcer/implementor mentioned in this Ordinance.

**SECTION 4. PROHIBITED ACTIVITIES / OFFENSE**

**(a)** It shall be unlawful for any minor to loiter and roam outside their residence at late hours from ten o'clock (10:00 pm) in the evening to four o'clock (4:00 am) in the morning within the jurisdiction of Santa Fe, Leyte.

**(b)** It shall be unlawful for a parent or guardian of a minor to knowingly permit, or by insufficient control, allow the minor to remain in any public place within the municipality during curfew hours.

**SECTION 5. EXEMPTIONS.** The activities prohibited by Section 4 shall not be prohibited in the following circumstances:

- 1) Going to or returning home, without any detour or stop, from activities attended by a minor such as school, religious, recreational, educational, social, community or other activity sponsored by the barangay, municipality, school or other similar private groups;
- 2) When the minor is in a motor vehicle or other travel in no violation of this ordinance;
- 3) When the minor is accompanied by his/her parent or guardian; and
- 4) When the minor is engaged in an authorized employment activity, or going to or returning home from the same, without any detour or stop.

**SECTION 6.** This Ordinance shall adopt the provision of Section 6 of Republic Act 9344 otherwise known as the Comprehensive Juvenile Justice and Welfare System on the minimum age of criminal responsibility which states that "A minor fifteen (15) years of age or under at the time of the commission of the offense shall be exempt from criminal liability. However, the minor shall be subjected to an intervention program pursuant to Section 20 of the same act. A minor above fifteen (15) years but below eighteen (18) years of age shall likewise be exempt from criminal liability and be subjected to an intervention program unless he/she has acted with discernment in which case, such minor shall be subjected to the appropriate proceedings in accordance with this Act. The exemption from

criminal liability herein established does not include exemption from civil liability, which shall be enforced in accordance with existing laws.

**SECTION 7. ENFORCEMENT.** The Philippine National Police (PNP), Barangay Tanod, or any recognized neighborhood crime watch enforcer are hereby authorized to enforce this ordinance. The law enforcer shall, before taking any enforcement action shall ask the apparent offender's age and reason for being in the public place. A citation ticket shall be issued to the violator after reasonably believing that a violation is committed and explaining the circumstance of such violation under this ordinance.

**SECTION 8. PENALTY.** Any minor that violates the provisions of this ordinance shall be fined in accordance with the following schedule:

1<sup>st</sup> Offense – Minor offender will be issued with citation ticket and be referred to the nearest police station, barangay hall or tanod outpost for reprimand before being properly turned-over to his/her parent/s or guardian/s;

2<sup>nd</sup> Offense – Minor offender and parent/guardian will be required to undergo counselling conducted by the barangay council together with MSWD of the municipality; PROVIDED, that the Barangay Council and the MSWD shall certify compliance by the concerned minor with this penalty; PROVIDED FURTHER, that the minor shall be required to submit the certification issued by the barangay council to the police station within a period of two (2) months from the date of the violation; aside from counselling, community service for two (2) hours on weekends will be imposed to the minor offender; and,

3<sup>rd</sup> and Succeeding Offense/s – PROVIDED FINALLY, that in violation of Section 4 (b) hereof by the parent/guardian shall be fined ONE THOUSAND PESOS (P1,000.00); and the offender minor under section 4 (a) shall undergo community service to the Barangay for four (4) hours on weekends.

**SECTION 9. SEPARABILITY CLAUSE.** Any provision or portion of this ordinance found to be violative of the constitution or any law, and consequently declare invalid, said invalid provision or part shall not impair the other provisions or parts thereof, thus shall continue to be in full force and in effect.

**SECTION 10. REPEALING CLAUSE.** Ordinances, rules and regulations which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed and/or modified.

**SECTION 11. EFFECTIVITY.** This ordinance shall take effect after thirty (30) days from the date a copy thereof is submitted to the Sangguniang Panlalawigan for review and/or approval. Provided that copies of the Ordinance have been posted in at least three (3) conspicuous places in the Municipality in compliance with the requirements set forth in the Local Government Code of 1991.

Hon. Amiel Enage: "Just to clarify about the coverage of the Ordinance, does these include the minors in the barangays?"

Mr. Romeo Grisola: "Yes, please refer Section II of the Ordinance."

Hon. Rodel Ajeto: "How about if the minor offender turns 18 years old the following day, is he/she still be covered by the penalty provision?"

Hon. Agnes Chuca: "Yes, because he/she is 17 years old at the time of the commission of the offense."

Chief of Police Proven Troy Castro: "I manifest that counselling is just a light penalty, the minor offender should be reprimanded and should be issued a citation ticket on the first and second offense."

Hon. Alvin Petilla: "I suggest to penalize the minor offender with a community service for two hours in the second offense and four hours in the third offense."

Hon. Agnes Chuca: "I also suggest to penalize the parents or guardian of the minor offender with a fine of Php 1,000 on the third offense and a community service for four hours."

Hon. Alvin Petilla: "I disagree because one thousand pesos (Php 1,000.00) is too much, they can't afford and suggested only Php 500 will be fined."

Punong Barangay Herminia Bercero: "If the fine is afforded to pay, then there will be repeated violations."

Hon. Agnes Chuca: "Hon. Bercero is right, I insist a fine of Php 1,000.00 to the parents or guardian at the 3<sup>rd</sup> offense but is no longer required of the community service."

Punong Barangay Deogracias Moron: "One thousand pesos (Php 1,000.00) is alright, I am amenable."
