Secretary, the attached Ordinance No. 01, S. 2023 of the SB of Capoocan, Leyte, recommending for the declaration of its validity pursuant to its power under Section 56 (c) of R.A 7160, for it is within the powers of the local council to repeal or amend its prior acts either expressly or by the passage of an essentially inconsistent resolution (Constantino v. Desierto, 288 SCRA 654). Provided, that, pursuant to the Commission On Audit (COA) Decision No. 94-050, February 15 1994, mentioned in paragraph 3, page 273 of the ~~Compendium on Local Autonomy and Local Government~~ (By: Alberto C. Agra, 1992-1997 Edition), "Public Funds may not be used for the payment of telephone services used at their residences by members of the sanggunian".

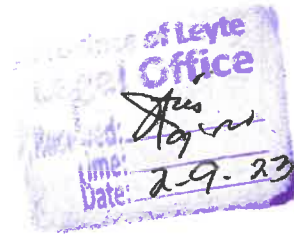

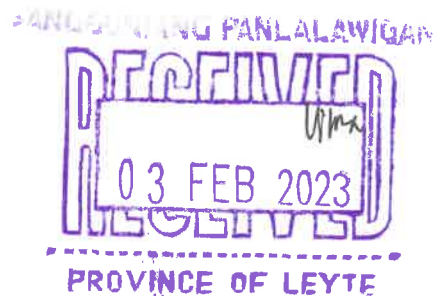


Section 3. Repealing Clause. Any ordinance found inconsistent hereof, in whole or in part, is hereby repealed or modified accordingly.
