

#### **MUNICIPAL ORDINANCE NO. 2022-11**

AN ORDINANCE INSTITUTIONALIZING THE 'KABATAAN KONTRA KRIMEN DROGAT TERORISMO (KK2DAT) PROGRAM" IN THE MUNICIPALITY OF PALO LEYTE AND FOR SUCH OTHER PURPOSES.

WHEREAS, Sec. 23. Art. II of the 1987 Constitution mandates the vital role of the youth in nation-building, particularly in the involvement in public and civic affairs;

WHEREAS, Section 20 of Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, provides the ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan which shall be disbursed by the SK solely for youth development and empowerment purposes;

WHEREAS, statistics based from the records of the Philippine Drug Enforcement Agency (PDEA) proves the fact that youths and innocent minors have been victims of illegal drugs related activities in the community, and languishing in a life deprived of liberty;

**WHEREAS**, the Kabataan Kontra Krimen, Droga at Terorismo (KK2DAT), should not only remain a mere program of the SK's but rather, it has to be an active institution that spearheads the function for a total reformation of the youths, developing them into productive citizens in a holistic approach.

**SECTION 1. TITLE**- this Ordinance shall be known as "An Ordinance Institutionalizing the Kabataan Kontra Krimen Droga at Terorismo (KK2DAT) Program in the Municipality of Palo and for such other purposes'.

**SECTION 2. DECLARATION OF POLICY**- It is hereby declared to be the policy of the municipality to promote and protect the physical, moral, spiritual, intellectual and social well-being of Filipino youth, inculcating in them patriotism and nationalism, and encourage their involvement in public affairs.

The **Municipality of Palo** recognizes the vital role of the youth to become proactive partners of the government in the nationwide campaign against illegal drugs and anti-terrorism by giving the most effective approach and awareness program across the 33 Barangay through the Kabataan Kontra Krimen Droga at Terorismo (KK2DAT) program of the Sangguniang Kabataan.

**SECTION 3. DEFINITION OF TERMS-** For purposes of this Ordinance, the following terms are hereby defined:

- (a) KK2DAT shall refer to Kabataan Kontra Krimen Droga at Terorismo
- (b) **Youth** shall refer to those persons whose ages range from fifteen (15) to thirty (30) years old as defined in Republic Act No. 8044. For the purpose of targeted programming for the youth, the age shall be considered as follows;

15-17 child youth

18-24 - core youth

25-30 -adult youth

- (c) Youth Organizations shall refer to those organizations whose membership/composition are Youth-Serving Organizations shall refer to those registered organizations whose principal programs, projects and activities are youth-oriented and youth-related, and whose composition are not limited to the youth. The organization shall be duly recognized or accredited by proper local government registering entities;
- (d) Child/Children refers to person below eighteen (18) years of age or those over but unable to fully take care of themselves or protect themselves from abuse, neglect, cruelty, exploitation or discrimination because of a physical or mental disability or condition;
- (e) **Drug** any chemical substance which alters the mood and behavior as a result of alterations in the function of the brain (World Health Organization);
- (f) the youth;

SECTION 4. INSTITUTIONALIZATION OF THE KABATAAN KONTRA KRIMEN DROGA AT TERORISMO.

(KK2DAT) - The implementation and adoption of the Kabataan Kontra Krimen, Droga at Terorismo (KK2DAT) program in the annual 10% SK Funds in the Barangay is hereby institutionalized as a basic program of the Sangguniang Kabataan as part of its youth development programs in every calendar year and shall be adopted in the Annual Barangay Youth Investment Program (ABYIP) and the Comprehensive Barangay Youth Development Plan (CBYDP).

SECTION 5. THE SALIENT FEATURES OF THE YOUTH KABATAAN KONTRA KRIMEN DROGA AT TERORISMO.

KK2DAT) PROGRAM- to ensure appropriate implementation of the Kabataan Kontra Krimen Droga at Terismo Program, the Sangguniang Kabataan are enjoined to observe and adopt the salient features of this program as follows:

- a) 5Cs of a Positive Youth Development
  - a. 1. Connection—a feeling of safety, structure and belonging, positive bonds with people and other social institutions.
  - a. 2. Confidence—a sense of self-worth and mastery, having a belief in one's capacity to succeed.
  - a. 3. Character—taking responsibility, a sense of independence and individuality, and connection to principle and values.
  - a. 4. Competence—the ability to act affectively at school, in social situations and at work.
  - a. 5. Contribution—active participation and leadership in variety of settings, making a difference.
- b) Republic Act 9165- policy of the State to safeguard the integrity of its territory, and the well-being of its citizenry, particularly the Youth.
- c) History and Main Objective of KK2DAT- aimed to be an organized youth movement that encourages and strengthens the youth's ability to minimize and or, gradually suppress the illegal drugs and terrorism problem in our country.
- d) Crime situation and statistical overview of the Municipality of Palo
- e) Lecture on the ill effects of prohibited drugs through Republic Act 9165 or the "Comprehensive Dangerous Drugs Act of 2002"
- f) Violence Against Women and Children (VAWC) awareness lecture
- g) Republic Act 8049 or the "Anti-Hazing Act of 1995"
- h) Republic Act 8353 otherwise known as the "Anti-Rape Law of 1997"
- i) Republic Act 9208 or the "Anti-Trafficking in Persons Act of 2003"
- j) Republic Act 10627 or the "Anti-Bullying Act of 2013"
- k) Republic Act 7877 of the "Anti-Sexual Harassment Act of 1995"
- I) executive Order No. 70 series of 2018 Institutionalizing the whole-of-nation approach in attaining the inclusive and sustainable peace, creating a national task force to end local communist and armed conflict, and directing the adoption of national peace framework.
- m) Republic Act 8044 or the "Youth in National Building Act of 1995"

SECTION 6. SECTION 6. IMPLEMENTATION OF THE KK2DAT PROGRAM- The Sangguniang Kabataan Federation as the mother organization of the SK Councils across the 33 barangays will spearhead the implementation of the KK2DAT Program for the roll-out and cascading across the 33 barangays in a form of lecture, training, youth leadership, summit or camp, and other educational setting, in partnership with the Philippine National Police (PNP), Armed Forces of the Philippines (AFP), Municipal Social Welfare and Development Office (MSWDO), the Municipal Youth Development Office (MYDO), Kabataan Kontra Krimen Droga at Terorismo (KK2DAT) Municipal and or Provincial Chapter, and other youth organizations, government agencies and offices, if deemed necessary.

**SECTION 7. THE ROLE OF THE SANGGUNIANG KABATAAN**- To ensure holistic participation of the youth sector and the residents in the barangay, the Sangguniang Kabataan shall mobilize and organize activities in accordance to the salient features of the KK2DAT Program and shall maximize creative medium such as slogan making contest, poster making contest, mural painting, video documentary contest, virtual or online contest, and other similar medium that highlights youth empowerment and youth development approaches.

**SECTION 8. FUNDING-** The Local Government Unit of Palo shall fund and incorporate in its annual budget amounting to P 100,000 for the Implementation of the Program, in accordance with the COA accounting and auditing rules and regulations.

**SECTION 9. INFORMATION DISSEMINATION USING MULTI-MEDIA PLATFORMS-** To ensure maximum audience reach among the youth sector in the grassroots level, multi-media platforms such as newspaper, radio, television broadcast, social media networking sites, and other forms of communication channels should be utilized to establish inspiration to more young people in the community and to create an enabling avenue that will serve as a credible source of information.

# SECTION 10. PARTNERSHIP TO OTHER STAKEHOLDERS AND NON-GOVERNMENT ORGANIZATIONS-

Partnerships and collaborations to interested stakeholders and other non-government organizations may also be done as part of the interventions to strengthen and ensure the effectivity of the program.

**SECTION 11. KK2DAT PALO LEYTE CHAPTER**- There shall be an organization to be known as KK2DAT Palo Leyte Chapter. The SK Federation President will automatically be the KK2DAT President and choose among its officers from the 33 SK Chairpersons in the Different Barangay

The officers are composed of President, Vice President, Secretary, Treasurer, Auditor and two (2) Public Relation Officer only. The Chapter may accept Youth who wants to become a member and/or Volunteer of the KKD2DAT Palo Leyte Chapter.

**SECTION 12. POWERS AND FUNCTION OF THE KK2DAT OFFICERS**- The officers of the Kabataan Kontra Krimen Droga at Terorismo (KK2DAT) in the Municipality exercise the powers and discharge such duties as follows:

- (a) Take the lead in cascading of policies and awareness campaign on the importance of the youth in nation building by teaching and empowering the students and youths to become proactive partners of the government in the nationwide campaign against criminality and terrorism.
- (b) Ensure the implementation of programs, projects and activities of the Sangguniang Kabataan through the Committee on Drug Abuse Council and its advocacies.
- (c) Coordinate with the sangguniang barangay and other youth organizations within her/his barangay on youth-related programs and projects that they wish to initiate and implement; and
- (d) Exercise such other powers and perform such other duties and functions as may be prescribed in Republic Act 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015.

**SECTION 13. SEPARABILITY CLAUSE**- If any provision of this Act is held invalid or unconstitutional, the same shall not affect the validity and effectivity of other provisions hereof.

**SECTION 14. REPEALING CLAUSE**- Pertinent provisions of all other laws, ordinances, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 15. EFFECTIVITY CLAUSE.** – This ordinance shall take effect upon its approval and after due compliance with the posting and publication requirements as provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
