

Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 02 CY 2022** of the **Municipality of La Paz**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 02 CY 2022** with a total appropriation in the amount of **P1,150,000.00** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 2 CY 2022. Further, that said reversion shall not adversely affect the fiscal standing of the LGU upon the closing of the books of accounts.
- 2. That the grant of Terminal Leave Benefits shall be subject to the provisions of Joint CSC-DBM Circular No. 1 s. 1990 and Budget Circular No. 2002-1 and the account code shall be 5-01-04-030.
- 3. That the granting of Service Recognition Incentive 2022 is subject to the provisions of Budget Circular No. 2022-4 dated December 20, 2022.
- 4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.


