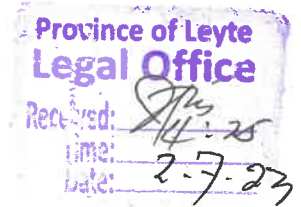

ORDINANCE NO. 14 SERIES OF 2022

**AN ORDINANCE INSTITUTIONALIZING THE LANTAWAN
FESTIVAL OF THE MUNICIPALITY OF CAPOOCAN, LEYTE
AND PROVIDING FUNDS THEREOF**

SPONSOR: HONORABLE EMMANUEL D. ARBOSO

WHEREAS, the LANTAWAN are watch towers built during the Spanish Era used to lookout for incoming pirates and enemies;

WHEREAS, the LANTAWAN is now considered a landmark of the municipality with historical significance that needs to be protected, restored and preserved;

NOW, THEREFORE, premises considered and on motion of Honorable Von Lito Q. Vallar, unanimously seconded, be it be it ordained by the Sangguniang Bayan of Capoocan, Leyte, in regular session assembled that:

Section 1. TITLE. This Ordinance shall be known as *"The Lantawan Festival Ordinance of the Municipality of Capoocan, Leyte"*.

Section 2. OBJECTIVE. The Local Government Unit of Capoocan, in its desire to establish and develop tourism as a support mechanism, and to strengthen promotion and advocacy, opens its doors to entice tourists, local and national, thus providing additional revenues/income and realize our vision to become the Tourism Hub of Leyte. It is the objective of this Ordinance to develop and preserve the *Lantawan* structures situated besides the municipal building as remnants of World War II.

Section 3. IMPLEMENTATION. The Local Government Unit is mandated to implement the *Lantawan Festival* every November 23 which is the Founding Anniversary of the municipality, by showcasing the Festival through presentation of street dances to be participated by the different schools, barangays or groups of the municipality. We can also invite contingents/participants from other municipalities to add to the festivity and momentum.

Section 4. TECHNICAL WORKING GROUP. A Technical Working Group shall be created to conduct study, planning and preparations, among others, for the achievement of a successful celebration of the *Lantawan Festival*. The Technical Working Group shall be composed of the following:

- Chairman: Municipal Mayor
- Members: Tourism Officer
- Municipal Planning & Development Coordinator

Section 4. FUNDING. The funding shall be sourced out from the Annual Budget chargeable against the Socio-Cultural which includes among others, *prizes, professional fees, rent expenses, other Supplies & MOOE*, to be spearheaded by the Municipal Tourism Office. **The 21 component barangays of the municipality are likewise enjoined to allocate funds in their Annual Budget for this purpose.**

Section 5. SEPARABILITY CLAUSE. If for any reason, any section or provision of this ordinance is declared institutional or invalid by a competent court, the remaining sections or provisions not affected thereby shall continue to be in full force or effect.

Section 6. REPEALING CLAUSE. All ordinances contrary to or inconsistent with this ordinance are thereby repealed or modified accordingly.

Section 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect after its approval.


