

## MUNICIPAL ORDINANCE NO. 13, S-2022-2025

AN ORDINANCE CHANGING THE POSITION TITLE OF MUNICIPAL ASSISTANT, DEPARTMENT HEAD I (LOCAL TREASURY OPERATION OFFICER-IV) TO LOCAL TREASURY OPERATION OFFICER-IV UNDER THE PLANTILLA OF PERSONNEL IN THE MUNICIPAL TREASURER'S OFFICE

#### **EXPLANATORY NOTE**

Republic Act 7160 or the Local Government Code of 1991 states that, every LGU shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

The Local Government Unit of Villaba has an existing plantilla position of Municipal Assistanct Department Head I (Local Treasury Operation Officer – IV) under the Municipal Treasurer's Office. However, the Director of the Civil Service Commission recommended that there is a need to change the position title since the hiring of the former position would require an approval from the Department of Finance considering that the position title is generic.

Hence, the passage of this ordinance.

## MUNICIPAL ORDINANCE NO. 13, S-2022-2025

**SECTION 1. – TITLE.** This ordinance shall be known as the "Changing of the Position Title from Municipal Assistant Department Head I (Local Treasury Operation Officer-IV) to Local Treasury Operation Officer-IV"

**SECTION 2. – POLICY**. It is the policy of the Local Government Unit of Villaba to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare

SECTION 3. – CHANGE OF POSITION TITLE. Plantilla Item No. 073 with a position title of Municipal Assistant Department Head I (Local Treasury Operation Officer- IV) under the Municipal Treasurer's Office shall be changed to Local Treasury Operation Officer-IV.

**SECTION 4. – REPEALING CLAUSE.** Any Ordinances which are in conflict with any provisions of this ordinance, are hereby repealed or modified accordingly.

**SECTION 5. – SEPARABILITY CLAUSE.** If for any reason, any section or provision of this ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions thereof.

SECTION 6. - DATE OF EFFECTIVITY. This Ordinance shall take effect upon approval.

**NOW THEREFORE**, on motion for approval by the Sangguniang Bayan Member Rogelio J. Baay, duly seconded en masse, this ordinance was approved.

This Ordinance was approved by the Sangguniang Bayan on November 14, 2022.
