A MUNICIPAL ORDINANCE ENACTED TO CHANGE THE NAMES OF CAIGITYTE BRIDGE AND CAIGIT RIVER TO PANGAS BRIDGE AND PANGAS RIVER AT BARANGAY POBLACION DEL NORTE, VILLABA, LEYTE

WHEREAS, Section 13, Paragraph (c), Sub - Paragraph (2) of the Local Government Code of 1991 (R.A. 7160) states that "The sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission (PHC), change the name of city, municipality and barangay roads, avenues, boulevards, thoroughfares and bridges;

WHEREAS, in the same Section, Paragraph (C), Sub - Paragraph 5, of this Code also states that "The sanggunians of Component cities and municipalities, in consultation with the PHC, maychange the name of any other public places or building owned by the municipal government";

WHEREAS, the naming of Caigit Bridge and Caigit River in Poblacion del Norte, this municipality, has no relevant historical and religious background in the locality; and

WHEREAS, said river is connected to the popularly known Pangas Falls and it is on this account that a bridge is constructed thereon, bearing the river's name;

NOW, THEREFORE, on motion by the Hon. Rogelio J. Baay, Chairman, SB Committee on Laws and Rules, duly seconded en masse, be it ordained by the Sangguniang Bayan of the Municipality of Villaba in regular session assembled that:

Section 1. Title. - This ordinance shall be known and cited as "An Ordinance Changing the Names of Caigit Bridge and Caigit River to Pangas Bridge and Pangas River at Brgy. Poblacion del Norte, Villaba, Leyte".

Section 2. Scope. - Nothing is covered in this ordinance save for the subject of interest or concern which is self-explanatory.

Section 3. Definition of Terms. - As used in this ordinance, the following terms are hereby

Section 4. Significance. - Originally, the bridge in Poblacion del Norte was named after that of the river flowing from the Pangas Falls. At the time the falls was discovered by some settlers along the river banks, the younger people nearby, enticed by its clear and cool falling water, loved to bathe and swim in the pool - like catchment of the falls and become frequenters of the area.

The bottomline is that the falls is part of the Villaba Town's history and heritage, wherefore, it is but right and just to call the stream emanating from the PANGAS FALLS AS PANGAS RIVER and dub the structured passageway across this river as PANGAS BRIDGE.

Section 5. Separability Clause. - Any provision or portion of this ordinance, found to be in violation of the Constitution or declared invalid by a competent court, shall be severed from this ordinance and said action shall not affect the enforceability of the remaining provisions or portions hereof.

Section 6. Repealing Clause. - All ordinances, rules and regulations, executive orders and other local enactments, which are inconsistent or in conflict with the provisions of this ordinance, are hereby repealed or modified accordingly.

Section 7. Effectivity. - This ordinance shall take effect immediately upon its approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code.

This Ordinance was approved by the Sangguniang Bayan on November 28, 2022.
