

Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 07 FY 2022** of the **Municipality of Capoocan**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 16**, **Series of 2022** with a total appropriation in the amount of **P1,262,000.00** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the grant of Gratuity Pay shall be made pursuant to the guidelines under Budget Circular No. 2022-5 dated December 28, 2022;
- 2. That the Supplemental Budget provides for the grant of the One-time Rice Assistance pursuant to AO No. 02. As the order states, the NFA, in consultation with DA and DBM shall issue the guidelines necessary to effectively implement the said order. However, as at the moment, the concerned agencies has yet to issue such, the implementation then of the appropriation for said grant to employees shall be subject to the guidelines to be issued by NFA, DA and DBM.
- 3. That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 7. Further, that said reversion shall not adversely affect the fiscal standing of the LGU upon the closing of the books of accounts.
- 4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.

Be it ordained in a Special Session assembled that:

- Section 1. The Supplemental Budget No. 7 of the Municipality of Capoocan, Leyte for Fiscal Year 2022 in the total amount of PhP1,262,000.00, is hereby approved.
- Section 2. Source of Funds. The sources of funds for Supplemental Budget No. 7 CY 2022 in the total amount of PhP1,262,000.00 shall be from the REVERSION of the MOOE SAVINGS in the total amount of PhP1,262,000.00
- Section 3. This Appropriation Ordinance authorizes the Local Chief Executive and the Presiding Officer of the Sangguniang Bayan to augment items in the approved Supplemental Budget No. 7 for CY 2022, within the same expense class, as needed.
- Section 4. Separability Clause: If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 5. Effectivity. This Appropriation Ordinance shall take effect upon its approval.
