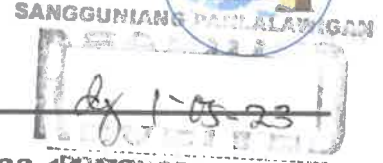

ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 07 CY 2022 IN THE AMOUNT OF ONE MILLION FIVE HUNDRED FORTY THOUSAND (P 1,540,000.00) PESOS FOR THE RELEASE OF GRATUITY PAY TO JOB ORDER WORKERS IN THE MUNICIPALITY OF HILONGOS PURSUANT TO ADMINISTRATIVE ORDER NO. 3 DATED DECEMBER 23, 2022 BY THE OFFICE OF THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND DEPARTMENT OF BUDGET AND MANAGEMENT BUDGET CIRCULAR NO. 2022-05, DATED DECEMBER 28, 2022

WHEREAS, the Office of the President of the Republic of the Philippines issued Administrative Order No. 3, dated December 23, 2022, authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in the Government for Fiscal Year 2022;

WHEREAS, said Administrative Order authorized the grant of Gratuity Pay to Contract of Service and Job Order Workers in the government who have rendered a total or aggregate of at least four (4) months of service as of December 15, 2022 can avail of not more than Five Thousand (P5,000.00) Pesos gratuity pay. For those who have rendered less than four (4) months may also be granted the one-time gratuity pay on a pro rata basis;

WHEREAS, on December 28, 2022, the Department of Budget and Management issued Budget Circular No. 2022-05 dated December 28, 2022 entitled Guidelines on the Grant of Gratuity Pay to Contract of Service (COS) and Job Order Workers;

NOW THEREFORE, BE IT ORDAIN AS IT IS HEREBY ORDAINED, by the Sangguniang Bayan in a Special Session, that:

Section 1. SUPPLEMENTAL BUDGET NO. 07 CY 2022 involving an amount of P 1,540,000.00 is hereby approved.
