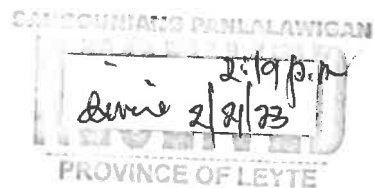



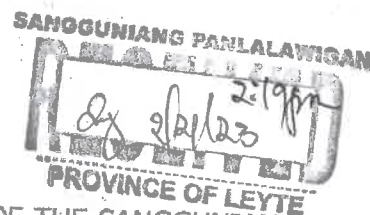

ORDINANCE NO. 2023-03

AN ORDINANCE REGULATING THE OPERATION OF "HABAL-HABAL" AND PEDICAB "POT-POT" OPERATING WITHIN THE JURISDICTION OF THE MUNICIPALITY OF DAGAMI, LEYTE, IMPOSING FEES, AND PENALIZING VIOLATORS THEREOF.

WHEREAS, motorcycle service, locally known as "Habal-habal" is not legalized by the National Government as a public vehicle;

WHEREAS, the riding public to avail the service particularly in the far-flung barangays or in the areas wherein there is no available transportation;

WHEREAS, the Municipality of Dagami recognize the services of habal-habal as means of transport in helping our people in their travel, especially those living in the mountain barangays;

WHEREAS, the Municipality of Dagami believes that there is a need to regulate the operation of the motorcycle service locally known as "habal-habal" to protect the lives of the riding public;

SECTION 1. TITLE – This ordinance shall be known as "HABAL-HABAL AND POT-POT ORDINANCE".

SECTION 2. DEFINITION OF TERMS - As used in this ordinance, the following terms are hereby defined as follows:

- a. Motorcycle – shall refer to the two-wheeled vehicle powered by an engine.
- b. Motorcycle-for-hire – shall refer to the motorcycle locally known as "habal-habal" privately owned and used to ferry passengers to their respective destinations in the locality.
- c. Reflectorized Stickers – refer to any adhesive material, decal, or metal object or device with a polished surface for reflecting light or providing illumination during nighttime.
- d. Zones –a contiguous land area or blocks, like a subdivision or a barangay where a motorcycle service (habal-habal) may operate without a fixed destination.
- e. Helmet – refers to any protective covering of the head used by the driver or motorist.


SECTION 3. REGISTRATION AND PERMITS.

- a. All Habal-Habal and Pot-Pot within the jurisdiction of Dagami, Leyte shall be registered in the PNP Office of Dagami, Leyte for record purposes.
- b. Stickers free of charge shall be issued in color coding upon registration to determine whether the said motorcycle is issued as habal-habal and pot-pot.
- c. The imposed herein shall be due on the first day of January and payable to the Municipal treasurer within the first twenty (20) days of January of every year. For pot-pot and habal-habal acquired after the first twenty (20) days of January, the permit fee shall be paid without penalty within the first twenty (20) days of the quarter following the date of purchase.
- d. There shall be collected from the owner of pot-pot and habal-habal operated within the Municipality, a permit fee of Five Hundred Thirty pesos and 50/100 (P530.50) per annum, exclusive of any other regulatory fees.

SECTION 4. RULES AND REGULATIONS FOR HABAL-HABAL

- a. The driver must be a holder of a driver's license issued by the LTO.
- b. The habal-habal must be duly registered with the LTO and must be renewed annually.



- c. No person or driver is allowed to drive or operate a motorcycle under the influence of liquor or a drunk driver while driving.
- d. Smoking is strictly prohibited for drivers and back riders while on a ride.
- e. The driver shall be responsible for the back riders.
- f. Carrying cargo must be determined by the driver based on the capacity and roadworthiness of the motorcycles.

SECTION 5. RULES AND REGULATIONS FOR POT-POT

- a. Drivers/Operators of pedaled tricycles must carry the passengers safely as far as human care and foresight can provide, using the utmost diligence of very cautious persons, with due regard for all the circumstances.
- b. Pot-pot should be equipped with reflectorized stickers for visibility, especially at night.
- c. Should be painted green for uniformity, and pot-pot numbers should be painted visibly in bold with a yellow color at the front back of the sidecar.

SECTION 5. LIMITATIONS.

- a. All motorcycle drivers shall negotiate with the speed of 40 KPH within the jurisdiction of Dagami, Leyte.
- b. The driver/owner shall install a silencer to prevent unnecessary disturbing noise.
- c. All motorcycle services shall bear a registration sticker for motor service to know that the unit is allowed to operate within the Municipality of Dagami.
- d. No child below 10 years old is allowed to board a motorcycle without a companion of either a parent or guardian.
- e. In an emergency, the driver shall determine the capacity of the motorcycle to carry his load.

SECTION 6. CONDUCT AND DUTIES OF MOTORCYCLE-FOR-HIRE. All motorcycle service drivers operating within the Municipality of Dagami, Leyte must wear protective riding gear while operating their motorcycles.

SECTION 7. ZONING AREA FOR OPERATION OF MOTORCYCLE SERVICE. The following zoning areas of the motorcycle will be determined by the Municipal Treasurer's Office, PNP Dagami, and Mayor's Office upon its implementation.

SECTION 8. TERMINAL SHED BUILDINGS - All motorcycle-for-hire service shall park all their motorcycles at the terminal shed building designated for this purpose.

SECTION 9. PENAL PROVISIONS - Violations of any of the provisions as provided in this Ordinance shall be penalized as follows:

- a. 1st Offense – 300PHP
- b. 2nd Offense – 500PHP
- c. 3rd Offense – 1000PHP plus the impounding of the motorcycle with an impounding fee of PHP 100.00 per day or imprisonment of not more than 30 days or both at the discretion of the court.

SECTION 10. REPEALING CLAUSE – All ordinances, rules, and regulations not consistent herewith are hereby repealed.

SECTION 11. SEPARABILITY CLAUSE. If for any reason any provisions or part of this ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

SECTION 12. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon the approval of the Sangguniang Bayan or the posting of copies in conspicuous places in the Municipality of Dagami, Leyte, and publication in a newspaper of local circulation.






