## **MUNICIPAL ORDINANCE NO. 2023-02**

OPCE KRISTYP. FLANCO

AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF BUSINESS PERMITS FROM JANUARY 20, 2023 TO MARCH 10, 2023 WITHOUT PENALTIES, SURCHARGES, AND INTEREST IN THE MUNICIPALITY OF HILONGOS

WHEREAS, pursuant to Section 192 of RA 7160, also known as Local Government Code of 1991 wherein local government units may, through an ordinance duly approved, tax exemptions, incentives, or reliefs under such terms and conditions as they may deem

WHEREAS, Section 167 of the same code provides that "xxx all local taxes, fees, and charges shall be paid within the first twenty (20) days of January or each of subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees, surcharges, or penalties but only for period not exceeding six (6) months;

WHEREAS, the Hilongos Retailers Association has requested for the extension of time for the filing and renewal of permits due to the new system adopted known as the iBPLS, and that the taxpayers are not yet accustomed to such system;

WHEREAS, owners of business establishments suffered losses due to the unpredictable weather conditions, whereby heavy rainfall occurred in weeks, thus the suspension of work and classes wherein most of their customers opted to stay at home instead of spending huge expenses for the holidays;

WHEREAS, due to such major justifiable reasons, and in line with the ANGAT KA HILONGOSNON on "Kindness and Care to constituents" it is only fair and just to give due course to the reasonable clamor of the business owners to extend the deadline for the payment of business permit fees, taxes, and/or charges in order to provide them with ample time to comply with their tax obligations and give them the opportunity to renew their respective business permits without penalties and/or charges;

WHEREAS, the Local Government of Hilongos thru the HI-BOSS is truly steadfast in the commitment to promote a business-friendly municipality in line with the "Attractiveness to investors", and sincerely recognizes the business sector as an indispensable, vibrant, and able partner towards the attainment of programs and development for economic growth;

NOW THEREFORE, BE IT ORDAINED by the Sixteenth Sangguniang Bayan of Hilongos in a regular session assembled that:

SECTION 1. COVERAGE - The deadline for the payment of the business permit is hereby extended from January 20, 2023 to March 10, 2023.

SECTION 2. APPLICABILITY - This Ordinance shall cover all business establishments operating within the territorial jurisdiction of the Municipality of Hilongos

- **SECTION 3.** Failure to comply and obtain the Mayor's Business Permit within the period of extension shall *ipso facto* cause the imposition of penalties and surcharges.
- **SECTION 4. REPEALING CLAUSE** All ordinances, local rules and regulations, or parts thereof, whose provisions conflict with, or inconsistent with any provision of this ordinance are hereby repealed, amended, and modified accordingly.
- **SECTION 5. SEPARABILITY CLAUSE** If for any reason any part or provision of this Ordinance shall be held unconstitutional or invalid, or any parts or provisions hereof which are not affected thereby shall continue to in full force and effect.

**SECTION 6. EFFECTIVITY CLAUSE –** This Ordinance shall take effect immediately upon its approval.
