

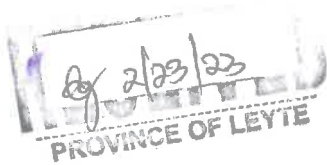

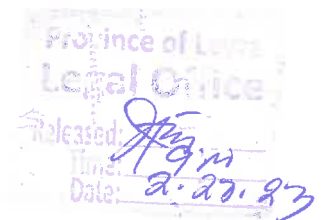

February 16, 2023



Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 01, S. 2023 of the Sangguniang Panlungsod of Baybay, Leyte, with the following comments/opinion:

1. That Ordinance No. 01, S. 2023 approves the transfer of the seat of government of the LGU concerned to a new site at its Government Center;
2. That said transfer of seat of government is based on the provision of Section II of the Code (R.A. 7160), as stated in the title of the ordinance;
3. That anent thereto, worthy of note is the pronouncement of Section II (b) of the Code quoted hereunder for reference:

*"Section II (b)-When conditions and developments in the local government unit concerned have significantly changed subsequent to the establishment of the seat of government, its sanggunian may, AFTER PUBLIC HEARING, and by a vote of two-thirds (2/3) of all its members, transfer the same to a site better suited to its needs:*

4. That perusal of subject Ordinance No. 01, S. 2023, the Provincial Legal Office (PLO) found NO proof that "Public Hearing" has been conducted. For example, the attachment of the "Minutes of Public Hearing", as proof thereof.

 1st Regular Session

**AN ORDINANCE APPROVING THE TRANSFER OF THE SEAT OF GOVERNMENT OF THE CITY OF BAYBAY, PROVINCE OF LEYTE, PHILIPPINES, TO THE NEWLY CONSTRUCTED 4-STOREY BUILDING AT THE GOVERNMENT CENTER AREA, BARANGAY GAAS, TO BE KNOWN AS THE CITY HALL OF THE CITY OF BAYBAY, LEYTE, PURSUANT TO SECTION 11 OF THE LOCAL GOVERNMENT CODE OF 1991.**

WHEREAS, the City Government appropriated for the purchase of land, the location of which is best suited to the present needs and anticipated future development and progress known as the Government Center;

WHEREAS, a 4-storey building was constructed in the Government Center area purposely to accommodate the offices and facilities of the local government unit and with its completion, the building is now ready for occupancy to serve its purpose as the new City Hall building;

WHEREAS, the old seat of government at the City Hall building located along R. Magsaysay Avenue will be vacated and transferred to the newly built 4-storey City Hall building at the Government Center area;

WHEREAS, for all legal intents, the new seat of government will now be at the newly built 4-storey building at the Government Center area, Barangay Gaas, and will be known officially as the City Hall of the City of Baybay, Province of Leyte, Philippines.

NOW THEREFORE, on motion of Atty. Jose Rommel A. Peñaranda, duly seconded, it is **HEREBY RESOLVED**, as it is hereby **RESOLVED**, to approve the transfer of the Seat of Government of the City of Baybay, Province of Leyte, Philippines, to the newly constructed 4-storey building at the Government Center area situated at Barangay Gaas to be known as the City Hall of the City of Baybay, Leyte, pursuant to Section 11 of the Local Government Code of 1991 and Rule 2, Article 7 of its Implementing Rules and Regulations.

**SECTION 1. TITLE.** This ordinance shall be known as **“AN ORDINANCE APPROVING THE TRANSFER OF THE SEAT OF GOVERNMENT OF THE CITY OF BAYBAY, PROVINCE OF LEYTE, PHILIPPINES, TO THE NEWLY CONSTRUCTED 4-STOREY**


**SECTION 2.** Separability Clause. – If any provision of this Ordinance is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

**SECTION 3.** Repealing Clause. – Pertinent provisions of all other laws, decrees, executive orders, and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4.** Effectivity Clause. – This Ordinance shall take effect after its publication in a newspaper of general circulation in the City.


