RESOLUTION NO. 2023-4433

RESOLUTION SUPPORTING HONORABLE BENJAMIN ABALOS. JR., SECRETARY THE OF DEPARTMENT THE INTERIOR OF LOCAL GOVERNMENT (DILG) ON HIS CALL ALL PHILIPPINE NATIONAL POLICE (PNP) GENERALS AND FULL COLONELS TO SUBMIT THEIR COURTESY RESIGNATION TO CLEANSE THE RANKS FROM ILLEGAL DRUG TRADE

WHEREAS, on January 4, 2023 Department of the Interior and Local Government (DILG) Secretary Benjamin "Benhur" D. Abalos has appealed to full colonels and generals of the Philippine National Police (PNP) to submit their courtesy resignations in support to the government's aims to cleanse their ranks from illegal drug ties;

WHEREAS, the call was upon the recommendation of PNP Chief General Rodolfo Azurin Jr. following concerns over the number of law enforcers allegedly linked to illegal drugs;

WHEREAS, accordingly, courtesy resignations are to be reviewed by a committee to determine the involvement or innocence of the officer in the illegal drug trade and that they will remain in the service as long as their courtesy resignations are not accepted by President Ferdinand R. Marcos, Jr.;

WHEREAS, this move is considered to be the fastest way to cleanse the ranks within the Philippine National Police considering the lengthy judicial process for erring officials;

NOW THEREFORE, on motion of Hon. Patricio F. Dumlao, Jr., unanimously seconded by all the Members present, be it,-

RESOLVED, that this Body supports, as it is hereby supporting the Honorable Benjamin "Benhur" Abalos, Jr., Secretary of the Department of the Interior and Local Government (DILG) on his call to all Philippine National Police (PNP) Generals and Full Colonels to submit their Courtesy Resignation to cleanse the ranks from the illegal drug trade;
