AN ORDINANCE REDEFINING THE BARANGAY BOUNDARIES IN THE CITY OF TACLOBAN

Be it enacted by the Sangguniang Panlungsod, City of Tacloban, Philippines, that:

Section 1. This Ordinance shall be called "The Ordinance Redefining the Barangay Boundaries in Tacloban City"

Section 2. **Barangay Libertad (1 & 4)** - Starting from junction Justice Romualdez, Salazar Streets and Sen. Enage Street to Panalaron Bay; thence along Panalaron Bay to Boundary of Leyte Park - Botanical Garden; thence along Boundary Leyte Park - Botanical Garden to Magsaysay Boulevard; thence along centerline Magsaysay Boulevard to junction Magsaysay Boulevard - M.H. del Pilar Street; thence along centerline M.H. del Pilar Street to junction M.H. del Pilar - Lopez Jaena Streets; thence along centerline Lopez Jaena Street to junction Lopez Jaena - Sen. Enage Streets; thence along centerline Sen. Enage Street to point of beginning.

Barangay 2 - Starting from junction M.H. del Pilar - Lopez Jaena Streets; thence along centerline M.H. del Pilar Street to junction M.H. del Pilar Street - Magsaysay Boulevard; thence along centerline Magsaysay Boulevard to perimeter fence of Leyte Park Hotel to the shoreline of Cancabato Bay; thence along the shoreline of Cancabato Bay to projected centerline of Transmitter Road; thence along projected and existing centerline of Transmitter Road to junction Transmitter Road - Paterno Extension; thence along centerline Lopez Jaena Street to point of beginning.

Barangay 3 - All properties designated and defined as Upper Nula nula per resettlement consolidation subdivision plan of the City Government.

Barangay 5 - Starting from junction T. Claudio Street - Callejon; thence along centerline Callejon to junction Callejon - Lopez Jaena Street; thence along centerline Lopez Jaena Street to Junction Lopez Jaena - M.H. del Pilar Streets; thence along the centerline M.H. del Pilar Street to junction M.H. del Pilar - T. Claudio Streets; thence along centerline T. Claudio Street to point of beginning.

Barangay 5-A - Starting from junction Sen. Enage - T. Claudio Streets; thence along centerline Sen. Enage Street to junction Sen. Enage - Lopez Jaena Streets; thence along centerline Lopez Jaena Street to Junction Lopez Jaena - Callejon; thence along centerline Callejon to junction Callejon - T. Claudio Streets; thence along centerline T. Claudio Street to point of beginning.

Barangay 6 - Starting from junction Justice Romualdez - M.H. del Pilar Streets; thence along centerline M.H. del Pilar Street to junction M.H. del Pilar Street - Bañez Road; thence along centerline Bañez Road projected to P. Paterno Extension; thence along P. Paterno Extension to junction P. Paterno Extension - Justice Romualdez Street; thence along centerline J. Romualdez Street to point of beginning.

Barangay 6-A - Starting from junction M.H. del Pilar - Lopez Jaena Streets; thence along centerline Lopez Jaena Street to junction Lopez Jaena Street - P. Paterno Extension; thence along centerline P. Paterno Extension to junction of projected centerline of Bañez Road - P. Paterno Extension; thence along projected and existing centerline of Bañez Road to to junction Bañez Road - M.H. del Pilar Street; thence along centerline M.H. del Pilar Street to point of beginning.

Barangay 99 (Dii) - Based on Tacloban Cadastre Number 220, bounded on the Northeast by Barangay Bagacay (93); on the Southeast by San Juanico Strait; on the Southwest by the properties of Margarita Cinco, Leyte Memorial Park, adjacent lot of Evangelista property; on the Northwest by Barangay San Roque.

Barangay 100 (San Roque) - Based on Tacloban Cadastre Number 220, bounded on the Northeast by Barangay 93 (Bagacay); on the Southeast by Barangay 99 (Dii); on the Southwest by Barangay 103 (Palanog); on the Northwest by the Municipality of Alang-Alang.

Barangay 101 (New Kawayan) - Based on Tacloban Cadastre Number 220, bounded on the North by Sta. Elena and Tagpuro; on the East by Old Kawayan; on the Southwest by Sto. Niño.

Barangay 102 (Old Kawayan) - Based on Tacloban Cadastre Number 220, bounded on the Northeast by Tagpuro; on the Northwest by Sto. Niño and New Kawayan; on the Southeast by San Juanico Strait; on the Southwest by San Isidro (Suhi).

Barangay 103 (Palanog) - Based on Tacloban Cadastre Number 220, bounded on the Northeast by Barangay San Roque (100); on the Southeast by Barangays Tigbao, (94), Palanog (37-A) Palanog (12), Basper (94-A) and Salvacion (104); on the Southwest by the Municipalities of Sta. ORDINANCE NO. 2012-11-142

A ORDINANCE DECLARING AND DELINEATING THE TERRITORIAL BOUNDARIES OF BARANGAY 109 AND BARANGAY 109-A, V & G SUBDIVISION, TACLOBAN CITY

Be it enacted by the Sangguniang Panlungsod, City of Tacloban Philippines, that:

Section 1. Territorial Boundary of Barangay 109. The territorial boundary of Barangay 109, V and G Subdivision, Tacloban City, is hereby delineated, as follows:

Beginning on the North bounded by Barangay Calanipawan, East by Barangay Calanipawan and Barangay 109-A. South by Barangay Calanipawan and Barangay Caibaan, West by Caibaan barangays and shall be more described-Starting from the East bounded at the centerline of Blocks 12 & 3 between Gorgonia Street (along Phase 1 to 2 of Brgy. 109) and Pantak Street (Phase 4 of Brgy. 109-A); along Southeast Block 10 Caimito Street (at Phase 3) and Block 5 Emerald Street (at Phase 6); along South Block 7 Ivory Street (at Phase 6); along Southwest Blocks 10 & 2 Pearl Street (at Phase 6); along West Block 3 Rimas Street and Block 12 Palmera Street (at Phase 3 & 2), Block 14 Ilang-Ilang Street and Block 7 Jasmin Street (at Phase 1); along North Block 4 Adelfa Street (at Phase 1), Block 1 Apitong Street and Phase 5 Extension (at Phase 5); along Northeast Block 6 Gorgonia Street (at Phase 1).

Section 2. Territorial Boundary of Barangay 109-A. The territorial boundary of Barangay 109-A, V & G Subdivision, Tacloban City, is hereby delineated, as follows:

Beginning at the West bounded at the centerline of Block 3 between Pantak Street (Phase 4 of Brgy. 109-A) and Gorgonia Street (Phase 2 of Brgy. 109) to include the open lot on the North, fronting Brgy. 96 Hall and Police Precinct straight to the North side of V & G Parish Church; along East (back of Flexihomes) Block 19 & 18, open space, Block 13 and Switzerland, Ireland London Blocks 11 & 9, Filipinas Blocks 8 & 11 (all at Phase 4 Extension); Southeast (back of Area 7) Blocks 16, 13, 15, 6, Pergola, grouted riprap (West of City Hospital), open space and Block 4; along South (back of Orbit
