Referred to the committee on Housing, Land Use and Informal Settlers is Resolution No. 52 of Brgy. Bunga, Baybay City. The said resolution is requesting the Sangguniang Panlalawigan of Leyte for an issuance of a resolution interposing no objection for the utilization of an old Spanish/Provincial Road as relocation site for displaced families due to calamities, and residence of informal settlers and as a site for Barangay Infrastructure Projects.

As observed by the committee, the only document accompanying the said request is a letter reply from the Community Environment and Natural Resources Office of Baybay City, requiring Barangay Bunga through Punong Barangay Roldan V. Piedraverde to submit additional documents in order that it could facilitate and assess the subject request.

This committee would like to stress that the purpose of the request is for the utilization an old Spanish/Provincial Road as relocation site for displaced families due to calamities, and residence of informal settlers and as a site for Barangay Infrastructure Projects. Hence, it is important to know whether or not the said site had passed or would pass the requirements for safety under existing laws as a relocation and future infrastructure site. The committee cannot determine the same at this time considering that no certification or study is attached thereto.

Further since the request involves an old Spanish/Provincial Road, the said request might also require an executive act and issuances of certain certifications or clearances from the concerned departments of the city and provincial local government units. It is then recommended that Brgy. Bunga, Baybay City submits the following **additional** attachments for the Sangguniang Panlalawigan to study and consider in its assessment.

- a. Endorsement from the Local Chief Executive of Baybay City with the following attachments:

  - d. Provincial Planning and Development Office Clearance.


For the meantime, this resolution request of Barangay Bunga, Baybay City is noted, subject to the submission of the above enumerated documents.

This has reference to the letter of Atty. Jose Raymund A. Acol, dated December 15, 2022 and calendared in the agenda of the regular session of the Sangguniang Panlalawigan on January 10, 2023.

The said letter of Atty. Jose Raymund Acol manifested that Spouses Gilbert Alcoro and Helenita A. Alcoro is requesting the Sangguniang Panlalawigan for a Resolution Interposing "*no objection*" because the aforementioned spouses is applying for the issuance of an Original Certificate of Title over a portion of an old abandoned provincial road, of which their residential house is erected.

Perusing the documents attached to the said letter of Atty. Jose Raymund A. Acol, the committee observed that the request of Spouses Gilbert Alcoro and Helenita A. Alcoro through Flordevina P. Polo is actually a request for a certification from the office the Governor for the status of the portion of the old abandoned provincial road located at Brgy. Villa Solidaridad, Baybay City, consisting an area of 419 square meters, as reported by the Provincial Assessor. The committee did not however find any request from Spouses Gilbert Alcoro and Helenita A. Alcoro for a Resolution Interposing "*no objection*", instead the said request was just construed by the Provincial Assessor as such after their ocular inspection in the area. It is observed likewise that the Provincial Assessor submitted the matter for the judgment of the Provincial Governor and no such decision from the latter is attached to the subject letter request.

If indeed, Spouses Gilbert Alcoro and Helenita A. Alcoro is requesting for a Resolution Interposing "*no objection*," it is important to stress that while the said resolution is issued by the Sangguniang Panlalawigan, the said request may actually require an executive act, since apparently this may involve a disposal of a property of the provincial government.

It is then recommended that Spouses Gilbert Alcoro and Helenita A. Alcoro submits a **formal request** for a Resolution Interposing "*no objection*"


