Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 12 S. 2023 of the SB of Jaro, Leyte, with the following comments/recommendation:

1. That the title of subject Ordinance No. 12, S. 2023, speaks of the "creation of a 24-hour Emergency Unit" at the Rural Health Center of the LGU concerned;
2. That perusal of the same ordinance however, revealed that Section 4 thereof is all about the "Creation of New Plantilla Position and funding of the same providing for the "Qualification" of said New Plantilla Positions, and the respective "Function" under Section 5 thereof. An act that is quite different from the intended purpose as stipulated in the title;
3. That nevertheless however, since subject ordinance also touches on the "creation of New Plantilla Positions", the same is recommended for declaration of validity pursuant to its power under Section 56 (c) of R.A 7160, the same being to the opinion of the Provincial Legal Office (PLO), an exercise of the power authorized under Section 447 (l), (viii) of the Code. Provided, that, the creation of New Plantilla positions does not violate the prohibition under Section 325 (a) and (g) of the Code.

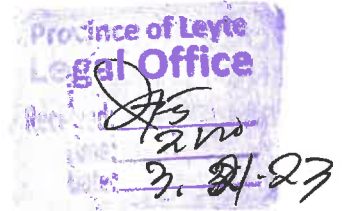

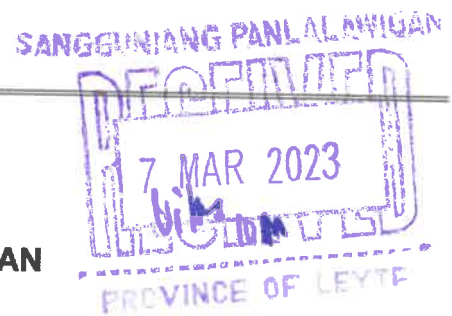

Pormida took the floor and said that considering that the proposed Ordinance NO. 12, Series of 2023 has already complied with the three-reading principle, and it has been appropriately reviewed under the committee level, and some of the amendments thereto are already included in the final draft, moves for the approval of Ordinance NO. 12, Series of 2023 under the third-and-final reading, and it was duly seconded en masse by the Body.

And then after the Chair declare that Ordinance NO.12, Series of 2023, which is for the creation of the RHU 24-Hour Emergency Unit for the Local Government Unit of Jaro, Leyte has formally been moved, carried and then approve en masse by the August Body, and then after extend his congratulations to Hon. Pormida for a job well-done.

ITEM NO. 2-EXECUTIVE AGENDA:

PROPONENT-HONORABLE LEO ANGELO T. PORMIDA

A PROPOSED RESOLUTION AUTHORIZING HONORABLE JASSIE LOU TAÑALA, LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH-EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-EV-CHD), REPRESENTED BY EXUPERIA B. Honorable Leo Angelo T. Pormida took the floor and then moves the above proposal, and it was duly seconded, and then the Chair declare for the plenary discussion.

Hon. Pormida opines and informed the Body that the emergency allowance is funded by the DBM intended for the eligible and none-eligible health care workers of the municipality under the Rural Health Unit (RHU).

Honorable Rey P. Aure asks from the proponent if the Barangay Health Workers (BHWs) are entitled to receive the aforesaid emergency allowances. Hon. Pormida replies that the Memorandum of Agreement does not include BHWs to receive the emergency allowance.

The Chair opines and said that the emergency allowances are for those health workers of the LGU directly connected with the RHU, and considering that its benefits will redound to the benefits of the RHU personnel, and considering further that the aforesaid proposal is not debatable request Hon. Pormida to offer the final motion.

Honorable Leo Angelo T. Pormida took the floor and then moves the above proposal, and it was duly seconded en masse by the August Body.

And then the Chair declare that Item NO. 02, has formally been moved, carried and then approve en masse by the August Body.

ITEM NO. 3-PROPONENT-HONORABLE JONELL MARTIN A. QUE
Committee Chairman on Rules, Ways and Means

A PROPOSED RESOLUTION EXTENDING THE DEADLINE FOR THE RENEWAL OF BUSINESS PERMIT FROM JANUARY 21, 2023 TO FEBRUARY 15, 2023, IN THE MUNICIPALITY OF JARO, LEYTE.

Honorable Jonell Martin A. Que took the floor and then moves the above proposal and it was duly seconded and then the Chair declare for the plenary discussion.

Hon. Que opines and informed the Body that as of this date the Licensing Office, has recorded only of about 12% renewal of business permits which is basically very low, *and he further suggests to the Body if it could be possible to extend the deadline longer up to February 28, 2023, in order to give ample time to the business sector to renew their business permit without paying penalties/surcharges.*

The Chair opines that the extension for the renewal of business permits becomes a traditional already for the LGU, the existing Municipal Tax Code provides the deadline for the renewal of business permit, which is until the 20th of January for every current year.

The Chair said further that there are instances that business operators renew their permit early; so that, they will not incur penalty; however their processing of their renewal document is up to the payment of the corresponding fees at the MTO; supposedly, according to the Chair they have to process their papers until the time the business certificate is issued by the Mayor's Office, it is perhaps the duty of the licensing office encouraging this business operators to complete the processing of their business permit.

Honorable Francisco R. Altres opines and then suggests to the Body that for the meantime is to approve the extension until February 15, 2023, for it is already made known to the LCE, for if the extension will be until February 28, 2023, as suggested the LCE has to be notified first, and there will be delay on the approval of the resolution.

Honorable Carmencita G. Tañala opines and for the consumption of the SB members said that among of the requirements for the renewal of business permit is the *Barangay Clearance*, and before the issuance of the barangay clearance, there is first conducted ocular inspection if they were compliant on the proper waste disposal in their respective vicinity, and if not, the barangay clearance is withheld until such time they will comply and/or practice the appropriate waste disposal.

Hon. Tañala continues that the Sangguniang Barangay has a plan to have a dialogue with the Licensing Officer, to discuss on what would be the effective cause of action to be undertaken with regard to this hard-headed business operator/s which are not following the standard procedure on waste disposal within their area of responsibilities.

The Chair opines and said that there is already a local law providing for the guidelines for waste disposals, and that he concurs to the plan of Hon. Tañala to educate this business operators on the proper way of waste disposal in their area, and as to the suggestions of Hon. Que to extend the deadline for the renewal of business permit until February 28, 2023, is favorably noted, for the proposal has to be conferred first to the LCE, but for the meantime is for the Sanggunian to approve first the proposed legislative measure, and then after asks Hon. Que to offer the final motion.

Honorable Jonell Martin A. Que took the floor and then moves the above proposal, and it was duly seconded en masse by the August Body.

And then the Chair declare that Item N0. 03, has formally been moved, carried and then approve en masse by the August Body.

ITEM NO. 4--PROPONENT--HONORABLE LANDILINO T. KATANGKATANG
Committee Chairman on Environmental Protection

A PROPOSED RESOLUTION ADOPTING THE MINUTES OF THE COMMITTEE MEETING OF THE COMMITTEE ON ENVIRONMENTAL PROTECTION TO REVIEW THE PROPOSED RESOLUTION URGENTLY REQUESTING THE PROVINCIAL SAND AND GRAVEL OFFICE THRU THE OFFICE OF THE GOVERNOR, THE MGB/DENR-REGIONAL OFFICE VIII, TO CONDUCT AN INVESTIGATION AND ON-SITE VALIDATION OF THE CURRENT STATUS OF THE CABAYONGAN RIVER DUE TO THE EXTRACTION OF SAND AND GRAVEL AND ITS IMPACT TO THE WATER SUPPLY, THE SAFETY OF THE RIVERSIDE COMMUNITIES, AND GOVERNMENT FLOOD CONTROL INFRASTRUCTURES IN THE MUNICIPALITY OF JARO, PROVINCE OF LEYTE.

Honorable Landilino T. Katangkatang took the floor and then moves the above proposal and it was duly seconded and then the Chair declare for the plenary discussion.

Honorable Katangkatang opines and informed the Body that the proposed resolution is in relation to the proposed ordinance for the suspension of SAG operations along the Cabayongan River, which have been temporarily deferred until such time there was an ocular inspection first to be conducted by the concerned offices, and for their recommendations in order to determine on the legality of the proposed ordinance, and if it is within the power of the Sanggunian to enact.

The Chair asks from Hon. Katangkatang pertaining to the status of the proposed committee meeting together with the different SAG-Operators which are operating along the Cabayongan River. Hon. Katangkatang replies that the proposed committee meeting will be scheduled on February 1, 2023 (Wednesday), and invitation letter will be send to the SAG-Concessionaires for their information, the committee meeting will only focus on the reconfirmation of their SAG-permit which have been granted by the previous composition of the Sangguniang Bayan

Honorable Francisco R. Altres took the floor and then asks from Hon. Katangkatang, if the Municipal SAG-Office is already aware pertaining to the unverified information reaching to his attentions, that there is an on-going extraction of boulders conducted by a certain SAG-Operator which is hauled to Carigara, then to Ormoc City and then transported to Bohol which is purportedly being used for the construction of a road.

Honorable Landilino T. Katangkatang replies that the Municipal SAG Office has no knowledge yet pertaining to such operations, and assures the Body that beginning February 1, 2023 the SAG Office will rigidly monitor the hauling of aggregates in order to check the veracity on the alleged extraction and hauling of boulders.

The Chair asks for any further discussion on the above proposal, and hearing no more asks Hon. Katangkatang to offer the final motion.

Honorable Landilino T. Katangkatang took the floor and then moves the above proposal, and it was duly seconded en masse.




