AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 109, S. 2020



PREFATORY STATEMENTS
Introduced By: Hon. Rogelio J. Baay

It is provided in Section 447 of the Local Government Code of 1991 (R.A. 7160) that "The sangguniang bayan as a legislative body of the municipality, shall enact ordinances, approve; resolutions and appropriate funds for the general welfare of the municipality and and its inhabitants pursuant to Section 16 of this Code."

Section 81 of the same Local Government Code declares that "The compensation of the local officials and personnel shall be determined by the sangguniang bayan concerned, PROVIDED, however, that the increase in compensation shall not exceed the limitations on budgetary allocations for personal services provided under Title Five, Book II of this Code,

NOW, THEREFORE, on motion by the Hon. Rogelio J. Baay, Sangguniang Bayan Member, be it ORDAINED, as the Sangguniang Bayan in regular session assembled hereby ORDAINED that:

Section 1. TITLE. – This enactment shall be known as An Ordinance Amending Section 3 of the Municipal Ordinance No. 109, S. 2020 Titled:

"AN ORDINANCE ABOLISHING THE VACANT POSITION OF ASSISTANT ASSESSOR AND THEREBY CREATING NEW ITEMS OF MIDWIFE I AND PHARMACIST I IN THE PLANTILLA OF PERSONEL OF THE MUNICIPAL HEALTH OFFICE"

Section 2. ORIGINAL PROVISION. – Section 3 of Municipal Ordinance No. 109, S. 2020 originally states that:

"Section 3. CREATION OF MIDWIFE I AND PHARMACIST I. – The new items of MIDWIFE I with salary grade 9 and PHARMACIST I with salary grade 10 are hereby created in the Municipal Health Office."

Section 3. AMENDMENT. – Section 3 of the Municipal Ordinance No. 109, S. 2020 shall hereby be amended to read as follows:

"Section 3. CREATION OF MIDWIFE I AND PHARMACIST I. – The new item of MIDWIFE I with salary grade 9 and PHARMACIST I with salary grade 11 are hereby created in the Municipal Health Office."

Section 4. SEPARABILITY CLAUSE. – If for any reasons, a part or provision of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effect.

Section 5. REPEALING CLAUSE. – Any ordinances, rules and regulations and executive issuances found inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 6. EFFECTIVITY. – This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places pursuant to the posting requirement of the Local Government Code.

On motion for approval of this Ordinance by Hon. Rogelio J. Baay, seconded by all members of the Sangguniang Bayan, this ordinance was approved.

RESOLVED, to enact:

MUNICIPAL ORDINANCE NO. 109, S-2020

AN ORDINANCE ABOLISHING THE VACANT **POSITION** OF **ASSISTANT** ASSESSOR AND THEREBY CREATING NEW ITEMS OF MIDWIFE-I AND PHARMACIST-I IN THE PLANTILLA PERSONNEL OF THE MUNICIPAL HEALTH OFFICE

Be it ordained by the Sangguniang Bayan in session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as the "Abolition of the vacant position of Assistant Assessor and thereby creating new items of Midwife-I and Pharmacist-I in the plantilla of personnel of the Municipal Health Office."

SECTION 2. ABOLITION OF ASSISTANT ASSESSOR. The vacant position of Assistant Assessor with salary grade 22, which is funded, particularly item no. 110, in the plantilla of personnel of the Municipal Assessor's Office is hereby abolished.

SECTION 3. CREATION OF MIDWIFE-I AND PHARMACIST-I. The new items of Midwife-I with salary grade 9 and Pharmacist-I with salary grade 10 are hereby created in the Municipal Health Office.

SECTION 4. APPROPRIATIONS. Funding of the newly created items shall be sourced from the funds of the abolished position of Assistant Assessor that shall not exceed the 55% budgetary limitation for P.S.

SECTION 5. HUMAN RECOURCE AND MANAGEMENT OFFICE (HRMO) MANDATE. The HRMO is hereby mandated to effect the necessary changes in the plantilla of personnel immediately upon the effectivity of this ordinance and shall faithfully observe the qualification standards as prescribed by the Civil Service Commission.

SECTION 6. DUTIES AND RESPONSIBILITIES. The duties and responsibilities of the said positions shall be determined by the Local Chief Executive consistent or in accordance with the general functions provided for by the Civil Service Commission.

SECTION 7. SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and in effect.
