# ORDINANCE NO. 23-04

AN ORDINANCE ESTABLISHING A FREE PHONE CHARGING STATION IN PUBLIC PLACES WITHIN THE MUNICIPALITY OF INOPACAN, APPROPRIATING FUNDS FOR IMPLEMENTATION THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Bayan of Inopacan, Leyte that;

**SECTION 1. Short Title.** This Ordinance shall be known as "The Free Public Phone Charging Station Ordinance of the Municipality of Inopacan"

**SECTION 2. Definition of Terms.** For the purpose of this Ordinance, the following terms shall mean and construed as:

- 1. Public Place shall mean new public market, covered court, terminals, tourism building, evacuation center, and solar charging stations located in Mahaba and Digyo Islets to which all the public individuals have access on it.
- 2. Phone Charging Station shall mean a designated place for charging a mobile device

**SECTION 3. Scope and coverages.** Tourists, customers, commuters as well as local constituents shall avail the privilege for free provided of this Ordinance.

**SECTION 4.** The Local Government Unit shall establish designated areas for phone charging station as follows:

- 1. New Public Market
- 2. Terminals
- 3. Tourism Building
- 4. Covered Court
- 5. Evacuation Center
- 6. Mahaba and Digyo Islets

**SECTION 5.** The Local Government Unit shall not be held liable in case of lost or damage of their belongings during phone charging.

**SECTION 6. Funding Source.** Funds to pay shall be chargeable against local government appropriation for fiscal year 2023. An initial funds shall be allocated in the amount of Fifty Thousand Pesos (Php 50,000.00) under Municipal Mayors Office (MMO) for its specific purpose.

**SECTION 7. Repealing Clause.** All Ordinances, Resolutions, Orders and/or rules and regulations inconsistent herewith are hereby modified accordingly.

**SECTION 8. Separability Clause**. If any section or provision of this Ordinance is declared void or unconstitutional, the remaining section or provision thereof shall not be affected by such declaration.

**SECTION 9. Effectivity Clause**. This ordinance shall take effect immediately upon approval.
