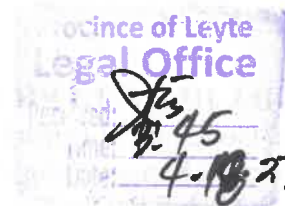

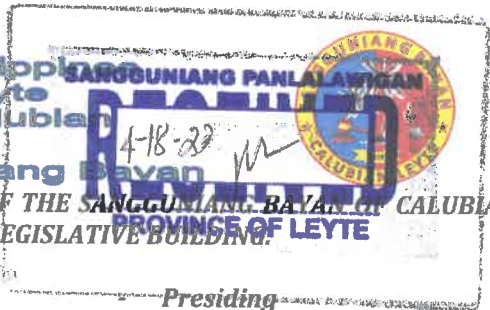

AN ORDINANCE APPROVING THE CONSTRUCTION OF THE CALUBIAN SUPER HEALTH CENTER LOCATED AT BRGY. VILLALON, CALUBIAN, LEYTE WHICH IS FUNDED UNDER THE HEALTH FACILITIES ENHANCEMENT PROJECTS (HFEP) FOR C. Y. 2023 OF THE DEPARTMENT OF HEALTH (DOH) IN THE AMOUNT OF TWELVE MILLION PESOS (P 12 MILLION).

WHEREAS, the Local Chief Executive in his letter dated March 10, 2023 addressed to the Sangguniang Bayan of Calubian, Leyte requested to pass a resolution requesting the Regulation, Licensing and Enforcement Division (RLED) for the construction of a health facility named as Calubian Super Health Center which will be erected at Brgy. Villalon, Calubian, Leyte;

WHEREAS, the OIC Mun. Health Officer of Calubian, Dr. Casey Jon G. Vea, also a Doctor to the Barrio (DTTB) in his letter to the Mun. Mayor of Calubian, Leyte dated March 10, 2023 had asked him his support of drafting a resolution authorizing the construction of a primary care facility with a name of Calubian Super Health Center on a 1,000 sq.m, agri., land donated by Ms. Amelia G. Eamiguel located at Brgy. Villalon, Calubian, Leyte;

WHEREAS, the proposed establishment of a Super Health Center at Brgy. Villalon, Calubian, Leyte would not only cater its various medical & health services for the residents of Brgy. Villalon, Calubian, Leyte, but also to other neighboring barangays of the northern part of the municipality which are distant away from NWLDH and the Calubian RHU;

WHEREAS, on the part of the Local Government of Calubian, Leyte, pursuant to Section 17 (b) (iv) of R.A. 7160 is enjoined to provide xxx (2) for a municipality xxx (iii) Subject to the provisions of Title Five, Book I of this Code, health services which include the implementation of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services; access to secondary and tertiary health services; purchase of medicines, medical supplies, and equipment needed to carry out the services herein enumerated;

WHEREAS, Section 447 (a)(5)(xiv) empowers the Sangguniang Bayan to approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities, that xxx (iv) Provide for the care of paupers, the aged, the sick, persons of unsound mind, disabled persons, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age and, subject to availability of funds, establish and provide for the operation of centers and facilities for said needy and disadvantaged persons;

NOW THEREFORE

BE IT ORDAINED by the Sangguniang Bayan of Calubian, Leyte in a session assembled, that :

SECTION 1. TITLE. - This ordinance shall be known as " AN ORDINANCE APPROVING THE CONSTRUCTION OF THE CALUBIAN SUPER HEALTH CENTER LOCATED AT BRGY. VILLALON, CALUBIAN, LEYTE WHICH IS FUNDED UNDER THE HEALTH FACILITIES ENHANCEMENT PROJECTS (HFEP) FOR C. Y. 2023 OF THE DEPARTMENT OF HEALTH (DOH) IN THE AMOUNT OF TWELVE MILLION PESOS (P 12,000,000.00)".

SECTION 2. RATIONALE. -A. It is hereby declared the policy of the municipality of Calubian, Leyte to ensure the efficient and effective delivery of the basic services and facilities, that particularly xxx (iv) Provide for the care of paupers, the aged, the sick, persons of unsound mind, disabled persons, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons, particularly children & youth below eighteen (18) years of age and, subject to availability of

B. Section 17 (a) of R. A. 7160, otherwise known as the Local Government Code of 1991 provides that xxx Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein. Xxx (b) Such basic services and facilities include, but are not limited to, the following: (2) For a municipality: xxx (iv) Social welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood & other pro-poor projects; nutrition services; & family planning services; xxx.

C. The Municipal Government of Calubian, Leyte supports the thrusts and programs of the Department of Health (DOH), an agency of the executive department of the government of the Philippines responsible for ensuring access to basic public health services by all Filipinos, through the provision of quality health care, the regulation of all health services and products.

D. The Municipal Government of Calubian, Leyte would be grateful to avail another program/project extended by the Department of Health (DOH) thru the Health Facilities Enhancement Projects (HFEP), a national program that assists in enabling government health facilities provide quality health care towards "Kalusugan Pangkalahatan" through the allocation of capital outlay for the procurement of health infrastructure and medical equipment.

E. The municipal government of Calubian, Leyte through its lead office, the Rural Health Unit of Calubian, Leyte and the Department of Health (DOH) is also committed to provide Immunization Program on COVID-19 vaccines and other essential vaccines for children & adults for their health, well-being & protection.

F. The Municipal Government of Calubian, Leyte fully supports the implementation of the programs, projects, development policies and or regulation covered under R. A. No. 11223, also known as the Universal Health Care Act, which mandates the institutionalization of health technology assessment (HTA) as a fair and transparent priority setting mechanism that shall be recommendatory to the DOH and PhilHealth for the development of policies and programs, regulation, and the determination of a range of entitlements such as drugs, medicines, pharmaceutical products, other devices, procedures and services for the welfare of all Filipino citizens.

SECTION 3. DEFINITION OF TERMS. - The following terms are defined in this ordinance, as follows:

A. Department of Health (DOH)- is an agency of the the executive department of the government of the Philippines, responsible for ensuring access to basic public health services by all Filipinos through the provision of quality health care, the regulation of all health services and products.

B. HFEP- Health Facilities Enhancement Projects (HFEP)- is a national program that assists in enabling government health facilities provide quality health care towards Kalusugan Pangkalahatan through the allocation of capital outlay for the procurement of health infrastructure and medical equipment;

C. R. A. 11223, also known as Universal Health Care Act - contains comprehensive and progressive reforms that will ensure every Filipino is healthy, protected from health hazards and risks, and has access to affordable, quality, and readily available health service that is suitable to their needs.;

E. Regulation, Licensing and Enforcement Division (RLED) of Department of Health (DOH) -, a part of its mandated functions, is to issue the needed Permit to Construct (PTC) the Health Facilities Enhancement Projects (HFEP) funded by the department;

F. Maternal and Child Health Care Program- includes the total packages of services provided to mothers and children. For the mother from prenatal, during delivery, up to the postpartum period; for the children, it will include babies from birth up to one (1) year of age;

G. Immunization services - is synonymous with vaccination. Vaccination is a simple, safe, and effective way of protecting people against harmful diseases, before they come into contact with them;

H. Reproductive health services - is synonymous with Family Planning- a reproductive health program that is committed to provide responsive policy direction and ensure universal access of Filipinos to correct information, medically safe, legal, non- abortifacient, effective and culturally acceptable modern Family Planning methods. It also caters on HIV and STI awareness, etc. ;

SECTION 4. Description of Calubian Super Health Center , its Programs, Functions & Services.

The Calubian Super Health Center is a new primary health care facility of Calubian, Leyte located at Brgy. Villalon, Calubian, Leyte.

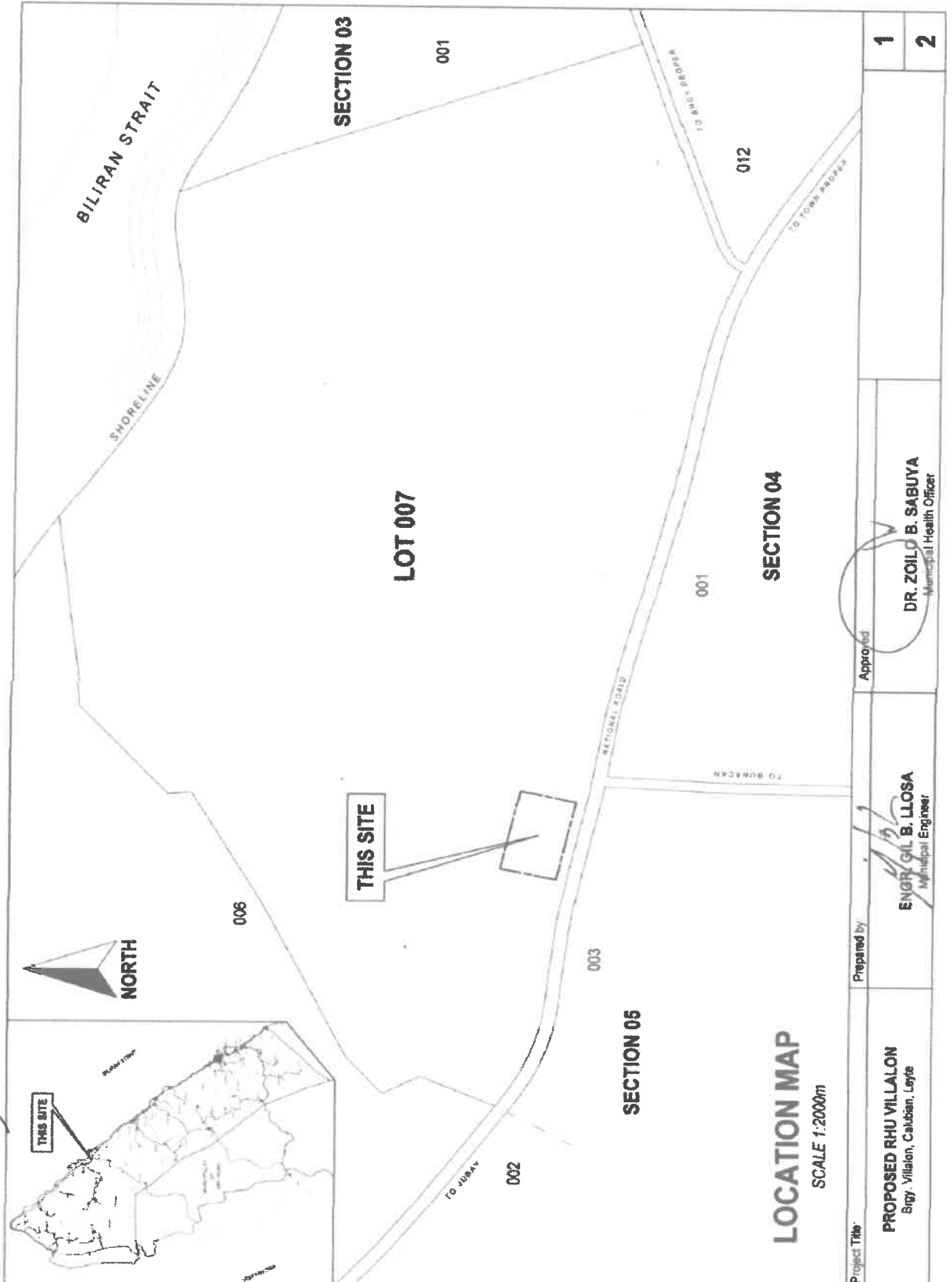

A. Location . The Heirs of the late Rosendo C. Eamiguel thru Ms. Amelia G. Eamiguel extended a donation of 1,000 sq.m. agri. land to the Municipal Government of Calubian, Leyte solely for the erection of this primary health care facility. The land donated is located at Brgy. Villalon, Calubian, Leyte and covered under Tax Dec. No.08-09-0052- 00125.

B. Particular Services & Programs to be offered, rendered and or provided by this Calubian Super Health Center are enumerated below, to wit:

- a. Immunizations;
- b. School based health services - reproductive health education, mental health education, etc.;
- c. Occupational health services- pre- employment, examination annual physical examination, etc.;
- d. Reproductive health care services - family planning , HIV and STI awareness, etc. ;
- e. Maternal & child health care services - prenatal care, postpartum care, etc. ;
- f. Basic laboratory services - CBC, urinalysis , etc. ; and
- g. Minor surgical procedures- circumcision, suturing of wounds, foreign body removal, incision and drainage).

D. SB Res. No. 2023- 68 of the Sanguniang Bayan of Calubian, Leyte dated March 13, 2023 has requested the Regulation, Licensing and Enforcement Division, Department of Health (DOH) to grant the needed Permit to Construct (PTC) for the Calubian Super Health Center to be established at Brgy. Villalon, Calubian, Leyte , a health facility covered under Health Facilities Enhancement Projects (HFEP) funded by the Department of Health (DOH).

E. Additional Area of Coverage - The Calubian Super Health Center at Brgy. Villalon, Calubian, Leyte would not only cater its various medical & health services for the residents of Brgy. Villalon, Calubian, Leyte, but also to other neighboring barangays of the northern part of the municipality which are distant away from Northwestern Leyte District Hospital and the Calubian Rural Health Unit;

SECTION 6. FUNDING ALLOCATIONS. Funding allocation for the Calubian Health Center shall be enumerated below, to wit :

A. Fund for Construction . The fund for the Construction of the Calubian Health Center in the amount of Twelve Million pesos (P 12,000,000.00) shall be granted by the Department of Health (DOH) thru the Health Facilities Enhancement Projects (HFEP) for C.Y. 2023.

B. Fund for Annual Operation, Maintenance & Other Expenses. The source of funds needed for the management, operation and other expenses of the Calubian Super Health Center from the start of its operation & to the succeeding years, will be shouldered/ provided by the Municipal Government of Calubian, Leyte under the Municipal Health Office, in the Annual Investment Program (AIP) of the municipality and from any sources of fund which may be given or granted by the Department of Health (DOH), the Provincial Government of Leyte or any government or non- government offices, and benevolent agencies or entities for that matter.

SECTION 7. REPEALING CLAUSE - All ordinances or resolutions , local issuances or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.


SECTION 8. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

SECTION 9. EFFECTIVITY- This Ordinance shall take effect immediately upon approval from the Honorable Sangguniang Panlalawigan of Leyte.





1. Villalon, Calubian, Leyte, but also to other neighboring barangays of the municipality which are distant away from NWLDH and the Calubian RHU;
4. The Sangguniang Bayan of Calubian, Leyte takes cognizance of the offer and generosity of the Donor, Amelia G. Eamiguel, Heir of the late Rosendo Eamiguel for the 1,000 sq.m. land covered under Tax Dec. No. 08-09- 052- 00125 to be used the erection of a Super Health Center; and
5. Section 444 (b)(1)(vi) of R. A. 7160 provides that xxx Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.
