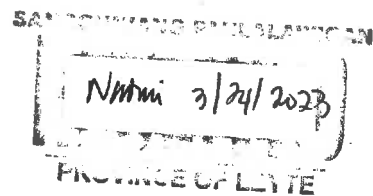



THEREFORE, on motion of BOT Elena Neduelan duly seconded by BOT Aurora Mison, be it;


