MUNICIPAL ORDINANCE NO. 03 SERIES OF 2023, ENTITLED "AN ORDINANCE AMENDING ARTICLE C. FEES AND CHARGES FOR SERVICE RENDERED BY THE MUNICIPAL HEALTH OFFICE PARTICULARLY ON THE LABORATORY FEES"

WHEREAS, presented for consideration before the Sangguniang Bayan is the Municipal Ordinance No. 03 Series 2023 "An Ordinance Amending Article C. Fees and Charges for Service Rendered by the Municipal Health Office Particularly on the Laboratory Fees";

WHEREAS, Section 15 of the Constitution of the Philippines provides that "The state shall protect and promote the right of the people and instil health consciousness among them";

WHEREAS, Section 16 of the local government code of 1991 provides that "Every local government unit shall exercise the powers granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for the efficient and effective governance and those which are essential to the promotion of general welfare;

WHEREAS, based on this mandate, the municipal government deemed it appropriate for the promotion and maintenance of health and sanitation in the locality;


