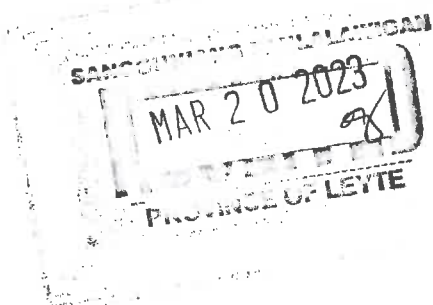

AN ORDINANCE ENACTED TO ABOLISH THE POSITION TITLE OF DRAFTSMAN OF LEYTE (PLANTILLA NO. 102) UNDER THE MUNICIPAL ENGINEERING OFFICE, AND CREATE A NEW PLANTILLA POSITION TITLE OF BOOKBINDER II (SALARY GRADE 04), TO BE ASSIGNED IN THE MUNICIPAL PLANNING AND DEVELOPMENT OFFICE

FUNDAMENTAL PRINCIPLES

Introduced by: Hon. Rogelio J. Baay

Section 3, (C), Chapter 1 of the Local Government Code of 1991 (R.A. 7160) provides that, "Subject to Civil Service Law, Rules and Regulations, the local officials and employees paid wholly or mainly from the local funds shall be appointed according to merit and fitness by the appropriate appointing authority."

As per Section 447, (a), (I), (VIII) of the same Local Government Code, the sangguniang bayan, in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, shall "Determine the positions and salaries, wages and other emoluments of officials and employees..."

Section 443, (c), (2) of the above-mentioned Code states that "The Sangguniang bayan may create such other offices as may be necessary to carry out the purposes of the municipal government."

Pursuant to the letter from the Human Resource Management Officer in reference to the instruction of the Municipal Mayor to request the August Body of this municipality to pass an ordinance for the abolition of the Position Title of Draftsman I (Plantilla No. 102) and the creation of a New Plantilla Position Title of Bookbinder II (Salary Grade 4), this pertinent matter and all the above - stated principles are grounds enough to sustain the enactment of this measure, thus,

BE IT DECREED, as the Sangguniang Bayan in regular session assembled hereby DECREED, that:

Section 1. TITLE. - This legislation shall be known as "An Ordinance for the Abolition of the Position Title of Draftsman I (Plantilla No. 102) and the Creation of a New Plantilla Position Title of Bookbinder II (Salary Grade 4)."

Section 2. ABOLITION OF POSITION. - The position title of Draftsman I in the plantilla of personnel of the LGU - Villaba is vacant and has long been unfilled to date. In this regard, the LCE manifested that the same shall be abolished.

Section 3. CREATION OF NEW POSITION. - There shall be created a new item of Bookbinder II, salary grade 4, in the Plantilla of Personnel for the Municipal Planning and Development Office.

Section 4. SOURCE OF FUNDS. – The appropriation for this newly created position shall emanate from the local government resource, particularly from the MOOE in the Municipal Mayor's Office.

Section 5. OBLIGATION OF THE HRMO. – The Human Resource Management Office is bound by a favor to cause to be operative this creation of new plantilla position, bringing into application the qualification standards set by the Civil Service Commission.

Section 6. REQUIREMENTS. – The following are the qualification standards for the position of Bookbinder II, Salary Grade 4 (Civil Service Commission):

Section 7. REPEALING CLAUSE. – Any ordinances, rules and regulations and executive issuances found inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 8. SEPARABILITY CLAUSE. – If for any reason, a part or provision of this ordinance shall be held unconstitutional or invalid by a court of law, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 9. EFFECTIVITY. – This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirements of the Local Government Code.

NOW THEREFORE, on motion for approval by the Sangguniang Bayan Member Rogelio J. Baay, duly seconded en masse, this ordinance was approved.

This Ordinance was approved by the Sangguniang Bayan on January 30, 2023.


