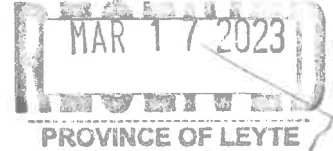

PREFATORY STATEMENT

WHEREAS, a study had been conducted on common charges/fees implemented by various public health facility across the region.

WHEREAS, based on the aforesaid study, the council had consensus to lower the prescribed fees and charges by 25% compared to those imposed in the health units of other cities, considering the highly critical economic condition of the people during the pandemic period.

WHEREFORE, on motion of Honorable Dr. Fulton Ike C. Arradaza, SP Chair on Health, and duly seconded by Honorable Philip L. Siu, and Honorable Ramon Ronald J. Veloso,

BE IT ORDAINED, by the 6<sup>th</sup> Sangguniang Panlungsod, this city, in its 6<sup>th</sup> Regular Session assembled on February 9, 2023 an ordinance as hereby is adopted, to wit:

**Section 1.** Title. This Ordinance shall be known as, "AN ORDINANCE FURTHER AMENDING CITY ORDINANCE NO. 003, SERIES OF 2016, AS AMENDED BY CITY ORDINANCE NO. 25, SERIES OF 2021".

**Section 2.** Section 4 of the Ordinance No. 25 series of 2021 is hereby amended to include a new term to wit.

Section 4. Definition of Terms. Xxxxxx

- I. Oxygen Concentrator (10L) – an adjustable Portable Oxygen Machine with the following technical specifications:
  - a) Oxygen concentrator – 10L
  - b) Flow – 1 to 10 LMP
  - c) Oxygen Concentration – 93% ± 3%

- d) Functions- used in the ICU or for patients with debilitating diseases and or cancer. Display total work hour, compressor auto on and off at the temperature, high- and low-pressure alarm. Optimal nebulizer, double blow.
- e) Power Consumption 425W

**Section 3.** Section 5 of Ordinance No. 25 Series of 2021 is hereby amended to include fees and charges for the use of oxygen concentrator (10L) as follows;


**Section 4. Separability Clause.** The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and in full force and effect.

**Section 5. Repealing Clause.** All ordinances, rules and regulations, or parts thereof, the provision of which are in conflict with or contrary to, the provision of this Ordinance are hereby repealed, amended and modified accordingly.

**Section 6. Effectivity Clause.** This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements as provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.

Be it ordained by the Sangguniang Panlungsod of Baybay in session assembled that:

SECTION 1.- Short Title - This ordinance shall be known as the Baybay City Medical, Diagnostic and Dialysis Center.








SECTION 5.- Implementing Rule, and Regulations.- The City Health Office as well as all heads/officers of the center shall jointly formulate rules and regulations subject to the approval of the Sangguniang Panlungsod.

SECTION 6.- Repealing Clause.- All ordinances, rules and regulations or part/parts thereof, in conflict with, or inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. - Separability Clause - If, for any reason or reasons, any part or provision of this Ordinance is declared unconstitutional or invalid, other parts or provisions thereof must affected thereby shall continue to be in full force and effect.

SECTION 8.- Effectivity Clause.- This Ordinance shall take effect 15 days after it publication in daily newspaper or general circulation and review of the Sangguniang Panlalawigan.



PREFATORY STATEMENT

WHEREAS, the recommended fees have been carefully and thoroughly studied based from common charges/fees used by all public health units;

WHEREAS, the members of this honourable council had a consensus to lower the prescribed fees and charges by 25% compared to those imposed in the health units of other cities, considering the highly critical economic condition of the people during the pandemic period.

WHEREFORE, on motion of Honorable Dr. Fulton Ike C. Arradaza, SP Chair on Health, and duly seconded by Honorable Philip L. Siu, and Honorable Ramon Ronald J. Veloso,

BE IT ORDAINED, by the 5<sup>th</sup> Sangguniang Panlungsod, this city, in its 30<sup>th</sup> Regular Session assembled on July 29, 2021, an ordinance as hereby is adopted, to wit:

Section 1. Title. This Ordinance shall be known as, "AN ORDINANCE AMENDING CITY ORDINANCE NO. 003, SERIES OF 2016, PRESCRIBING REASONABLE MEDICAL AND DIAGNOSTIC SERVICES FEES ADMINISTERED BY THE CITY GOVERNMENT OF BAYBAY".

Section 2. Declaration of Policy. It is the declared policy of the City of Baybay to promote and protect the health of all Baybayanons and the neighboring population who choose to be served by the health facilities of the city by providing them with first-rate health services that are suitable, accessible and affordable.

Section 3. Scope and Coverage. This Ordinance shall be effective within the territory of the city of Baybay and covers all Baybayanons and patients coming from the neighboring areas and towns of the 5<sup>th</sup> District of Leyte who wish to avail of the health services of the city.

**Section 4. Definition of Terms.** Whenever any of these terms or words is used in any section or provision of this ordinance, it shall have the meaning given in this section.

- a. BCMDDC – Baybay City Medical Diagnostic and Dialysis Center

- c. Common – shared by or done often, prevalent
- d. Fees – payments made to a professional person or public body in exchange for services or advice
- e. Health Facility – places that provide health care
- f. Reasonable – rational, appropriate, fair
- g. Services – a system supplying a public need such as health or utilities
- h. WLPH – Western Leyte Provincial Hospital

For patients occupying a private room in the WLPH, a five (5%) percent premium shall be added to their laboratory and pharmacy bills.

Dialysis Fees and Charges, both for High Flux and Low Flux Dialyses, remain unchanged and are kept at the levels authorized in City Ordinance No. 003, series of 2016.

The city mayor may, at his discretion, or upon recommendation of the CSWD, authorize discounts to senior citizens, students, PWD's, LGU employees and indigent persons of as much as twenty percent (20%).

Additionally, Baybay City residents who are BMIS identification card holders shall also be entitled to a 10% discount on all the service fees listed here.

**Section 6. Private Practice and Professional Fees of Government Physicians.** This section adopts the procedures prescribed by the Department of Health (DOH) Administrative Order No. 92, series of 2003, "Revised Policies and Guidelines on the Private Practice of Medical and Paramedical professionals in Government Health Facilities (Annex A)," especially those that refer to government physicians occupying plantilla positions; who are qualified/ eligible for private practice (III and IV.A.), requirements for application for private practice (IV.B.), procedure for certification of issuance of permit for private practice (IV.C.), hospital policies and procedures related to professional fees with special reference to IV.D.5. and special provisions (V.).

Private physicians who wish to practice or bring their patients for admission to the hospital shall sign a Memorandum of Agreement (MOA) indicating therein the terms and conditions of this privilege. The MOA shall be signed between the City Mayor and the doctor practitioner subject to the recommendation of the Chief of Hospital.

The professional fee charged and collected, in this case, shall be between the patient and the private doctor.

**Section 7. Payments.** All payments for services rendered by any of the public health units shall be paid to the treasurer of the city or duly authorized representatives. Collections from these service fees shall be deposited to the general fund, except those specifically identified in Section 5 (Slight Physical Injury, Less Serious Physical Injury, Serious Physical Injury and Necropsy/Post-Mortem Exam) for deposit to a trust fund.


**Section 8. Separability Clause.** The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and in full force and effect.

**Section 9. Repealing Clause.** All ordinances, rules and regulations, or parts thereof, the provision of which are in conflict with or contrary to, the provision of this Ordinance are hereby repealed, amended and modified accordingly.

**Section 10. Effectivity Clause.** This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements as provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.


