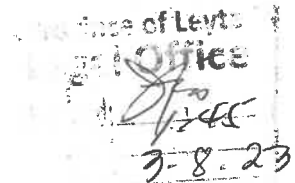

REPEALING CLAUSE. All ordinances, local issuances or rules inconsistent with the provision of This Ordinance are hereby repealed or modified accordingly.





Section 5. EFFECTIVELY CLAUSE. This Ordinance shall take be effect upon approval thereof.




