371 Province of Leyte for the period from January 1, 2022 to

375 Mr. Chair, this is a Report of COA concerned to check whether the Provincial
376 Government is in compliance with the 20% Development Fund utilization. That is
377 whether or not the provincial government has expended the 20% Development Fund for
378 ineligible expenses. Since we have a copy of the Report, I would like to read into the
379 record the conclusion, to wit:

380 "Based on the record performed, the Provincial Government of Leyte did not
381 utilize their 20% Development Fund for ineligible expenses in compliance with Item
382 3.2.5 of DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020.

383 The registries of allotment and obligations for the current and continuing appropriations,

384 as well as other financial documents, confirmed that all charges and disbursements
385 from the 20% DF were utilized for infrastructure and socio-economic development
386 programs and projects of the Provincial Government of Leyte, including financial
387 assistance to barangays and other LGUs, as counterpart for their respective
388 infrastructure projects.”
