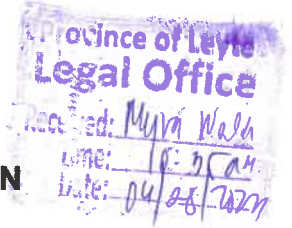

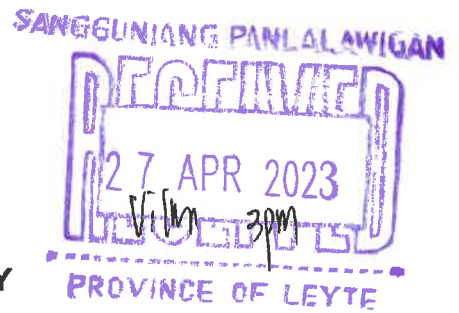

**“AN ORDINANCE CREATING ONE (1) PLANTILLA POSITION FOR SUPERVISING EMPLOYMENT OFFICER WITH SALARY GRADE 22 UNDER THE PUBLIC EMPLOYMENT SERVICE OFFICE OF THE MUNICIPALITY OF ALANGALANG”**

On motion of SB Member Jan Reian Saavedra duly seconded by Hon. Claire Yu, Hon. Sheila Antoni-Rebato and Hon. Ricardo Neil Eusores.

**WHEREAS**, Section 3 of R.A. 8759, otherwise known as the “PESO Act of 1999” provides for the establishing of Public Employment Service Office to carry out full employment and equality of employment opportunities for all and expand the existing employment facilitation service machinery in the municipal level;

**WHEREAS,** Section 5 of the local of Ordinance Institutionalizing the Alangalang Municipal Government Public Employment Service Office (PESO), The PESO shall be headed by PES Officer who shall be appointment by the Local Chief Executive from existing personnel who he/she deems fit to serve as such and, in accordance to the requirement prescribed by the Civil Service Commission (CSC). The municipal government upon the recommendation of the PES Officer shall provide additional staffing requirement in the PESO and shall be appointed by the Mayor in whatever status deemed appropriate and in accordance with CSC rules and regulation;

**WHEREAS,** the PES Officer shall function in accordance to the stated duties and responsibilities in Section 6 of the Ordinance Institutionalizing the Alangalang Municipal Government Public Employment Service Office (PESO);

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN** of the Municipality of Alangalang in session assembled that:

**Section 1.** There is hereby created the plantilla position for one (1) Supervising Employment Officer with Salary Grade 22 for the Public Employment Service Office for the Municipality of Alangalang;

**Section 2.** Qualification for the said position shall be based on the standards set by the Civil Service Commission:

**Section 4. REPEALING CLAUSE.** All ordinances, local issuances or rules inconsistent with the provision of this ordinance are hereby repealed or modified accordingly.

**Section 5. EFFECTIVITY.** This ordinance shall take effect upon approval thereof.




