

WHEREAS, Section 5 of the local of Ordinance Institutionalizing the Alangalang Municipal Government Public Employment Service Office (PESO), The PESO shall be headed by PES Officer who shall be appointment by the Local Chief Executive from existing personnel who he/she deems fit to serve as such and, in accordance to the requirement prescribed by the Civil Service Commission (CSC). The municipal government upon the recommendation of the PES Officer shall provide additional staffing requirement in the PESO and shall be appointed by the Mayor in whatever status deemed appropriate and in accordance with CSC rules and regulation;




