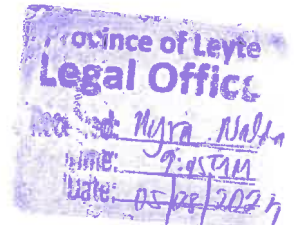

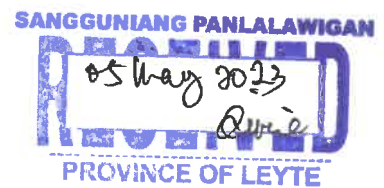

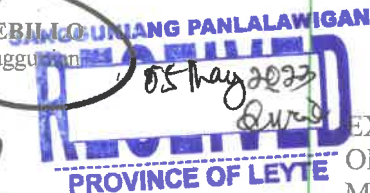

EXPLANATORY NOTE

WHEREAS, the Municipality of Mayorga recognizes the importance to have a logo/seal that will represent the principles and aspirations of the Local Government Unit as a whole;

WHEREAS, the logo/seal is likewise necessary to identify official transactions, documents and representations of the Local Government Unit;

WHEREFORE, on motion by the **Hon. Jairo C. Beltran** duly seconded by the **Hon. Mark Cloyd M. Tan-piengco**; be it

SECTION 1. TITLE.

This ordinance shall also be known as the "OFFICIAL SEAL ORDINANCE OF MAYORGA, LEYTE."

SECTION 2. PURPOSE.

The purpose of this ordinance is to provide identity for the Local Government Unit of Mayorga through an official seal to authenticate the municipality in its official transactions.

SECTION 3. AUTHORITY.

This Ordinance is enacted pursuant to the provisions of R.A. 7160 otherwise known as the Local Government Code of 1991 which mandates the LGU to adopt adequate measures to protect, safeguard and improve quality of life for every Mayorgueño by imposing appropriate penalty for acts that dishonor the identity of the LGU.

SECTION 4. OFFICIAL SEAL.

The Official Seal of the Municipality of Mayorga, Province of Leyte shall be as depicted below:



The Official Seal of the Local Government Unit of Mayorga, Province of Leyte displays a shield with a sun at the center and the images of the farm and the sea on its corners.

SHIELD – The shield symbolizes the duty of the Local Government Unit of Mayorga to defend the general welfare of all Mayorgueños through the delivery of efficient and effective provision of the basic services;

EIGHT-RAYED GOLDEN SUN – The eight-rayed golden sun at the center is adopted from the Philippine Flag which symbolizes unity, freedom, people's democracy, and sovereignty while the eight (8) rays symbolizes the first eight

FARM AND SEA IMAGES – The farm and sea images symbolizes the major livelihoods in the Municipality of Mayorga, Leyte;

GREEN CIRCLE ROPE – The green color represents growth and harmony while the rope symbolizes close relationship and cooperation among the constituents.

SECTION 5. USAGE OF THE OFFICIAL SEAL.

Only the Local Government Unit of Mayorga, its officials and employees shall have the authority to use the Official Seal for the following purposes:

- 5.1. As personality of the Local Government Unit of Mayorga in all of its affairs whether internal or corporate affairs and within or outside of its territorial jurisdiction;
- 5.2. To authenticate all LGU official and public documents and other administrative and executive issuances; and
- 5.3. As letter heading in all LGU official communications or correspondence.

SECTION 6. CUSTODIAN OF THE ORIGINAL LAYOUT OF THE SEAL.

The Secretary to the Sangguniang Bayan shall have the custody to the original layout of the official seal of the Municipality of Mayorga, Province of Leyte and shall also be responsible in the registration and filing of the Official Seal to the National Historical Commission of the Philippines or any appropriate agencies.

SECTION 7. PROHIBITED ACTS IN THE USE OF THE OFFICIAL SEAL.

The following acts are declared unlawful, prohibited and deemed punishable by this ordinance:

- 7.1. By any act or omission, mutilate, deface, defile, trample on, or cast contempt with the intention to dishonor or ridicule the Official Seal;
- 7.2. To display the Official Seal under any frame or picture of a person or profile picture of social medias, like Facebook and others, except for LGU government official representations;
- 7.3. To display the Official Seal in a platform or stage during programs or activities not directly or indirectly hosted by the Local Government Unit of Mayorga, unless upon the permission of the LGU;
- 7.4. To add any word, figure, mark picture, design, drawings, advertisement, or imprint of any nature which causes or likely to cause degradation on the Official Seal;
- 7.5. To print, paint or attach representation of the Official Seal whether full or partial on t-shirts, handkerchief, fan or other

7.6. To use or display the Official Seal as part of seminar, conferences, research or any activity except when undertaken by the Local Government Unit of Mayorga;

7.7. To use or display the Official Seal as part of any advertisement or infomercial except when undertaken by the Local Government Unit of Mayorga;

7.8. To be used for commercial or business purposes, except upon the authority of the LGU;

7.9. To be used by any organization or association whether for legitimate purpose, except when approved by the Local Government Unit of Mayorga;

7.10. To use the Official Seal for unlawful purposes;

7.11. To use the Official Seal as personal seal of any government official; and

7.12. Any other circumstances of a similar in nature and analogous to those above-mentioned.

SECTION 8. MODIFICATION IN THE DESIGN OF THE MUNICIPAL OFFICIAL SEAL.

The Official Seal, its symbols, including its colors shall not be modified, unless:

8.1. By enactment of an Ordinance modifying the same;

8.2. Any modification shall be made for in accordance with the vision of the Municipality and only once every ten (10) years.

SECTION 9. DRY SEAL OF THE LOCAL GOVERNMENT UNIT OF MAYORGA.

There shall be an adopted official dry seal in authenticating or subscribing official and public documents or administrative and executive issuances. The dry seal shall contain the official seal of the Local Government Unit of Mayorga.

SECTION 10. PROHIBITED ACTS IN THE USE OF THE DRY SEAL.

The following acts are declared unlawful, prohibited and deemed punishable by this ordinance:

10.1. Use by any office/s other than the Office of the Municipal Mayor;

10.2. Affix the dry seal on a paper unauthentic, unofficial and not a public document;

10.3. Affix the dry seal on a document for unlawful purpose/s;

10.4. Affix the dry seal on a document done outside the office or office hour;

10.5. To use the dry seal as personal dry seal of any official; and

10.6. Any other circumstance of a similar in nature and analogous to those abovementioned.

SECTION 11. PENALTY CLAUSE

Any person natural or juridical who by acts or omission violates the prohibited acts stated above shall be punished through the imposition of the following fines and penalties:

First Offense	Php 1,000.00
Second Offense	Php 2,000.00
Third Offense	Php 2,500.00 or an imprisonment of not less than one (1) month nor more than six (6) months, or both at the discretion of the court.

Furthermore, the penalty under this Ordinance shall not prejudice the filing of a separate criminal, administrative or civil liability.

SECTION 12. SEPARABILITY CLAUSE

If for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or otherwise invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 13. APPLICABILITY CLAUSE

All other matters related to the impositions of this ordinance shall governed by the pertinent provisions of existing laws and other ordinances.

SECTION 14. REPEALING CLAUSE

All Ordinances Rules and Regulations, or parts thereof, in conflict with, or inconsistent with any provisions of this ordinance are hereby repealed and modified accordingly.

SECTION 15. EFFECTIVITY CLAUSE

This Ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Leyte.
