

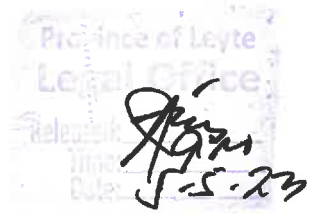

Respectfully returned to the Sangguniang Panlalawigan of Leyte through the SP Secretary, the attached Ordinance No. 2023-04, of the SB of Julita, Leyte, with the following comments/recommendation:

1. That Ordinance No. 2023-04 creates the "Persons with Disability Affairs Office (PDAO)";
2. That the basis for the creation thereof, is Section 1 of R.A 10070 as mentioned in the 5th "WHEREAS" of subject ordinance;
3. That upon the other hand, Section 1, (b), (2) of R.A 10070 is quoted hereunder for reference:

"Section 1 (b), (2) - Focal Person- In consideration of budget restraints, local chief executives of Fourth (4th), Fifth (5th) and Sixth (6th) class municipalities may in lieu of the creation of a PDAO, designate a focal person who shall perform the functions of the PDAO. x x x x."

4. That the municipality of Julita, Leyte, is a Fifth (5th) class municipality pursuant to a "List of Municipalities by Class", furnished by the Provincial Assessor's (PASSO) Office;
5. That pursuant to Section 325 (a) of the Code (R.A 7160), " the total appropriations, whether annual or supplemental, for personal services of a local government unit for one (1) fiscal year shall not exceed forty-five percent (45%) in the case of first to third class provinces, cities, and municipalities, and Fifty -five percent (55%) in the case of fourth class or lower, of the total annual income from regular sources realized in the next preceding fiscal year."

6. That in view hereof, it is recommended that instead of the creation of a "Person with Disability Affairs Office (PDAO)", a "Focal Person" be designated considering that the LGU of Julita, Leyte, is a Fifth (5th) class Municipality.

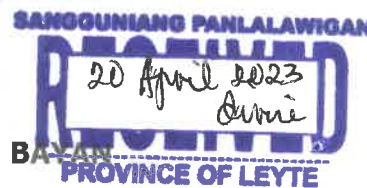

RESOLVED AS IT IS HEREBY RESOLVED, to ENACT the herein ORDINANCE:

MUNICIPAL ORDINANCE NO. 2023-04

AN ORDINANCE CREATING THE PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO) OF THE MUNICIPALITY OF JULITA, LEYTE.

WHEREAS, consistent with local autonomy and decentralization as mandated under RA No. 7160 also known as the Local Government Code of 1991, Local Government Units shall endeavor to be self-reliant and shall exercise such powers and discharge such other functions and responsibilities for the provision of basic services and facilities;

WHEREAS, Section 76 of the Local Government Code of 1991 provides that, "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribe by the Civil Service Commission;

WHEREAS, Section 443 © of the Local Government Code of 1991 likewise provides that "The Sangguniang Bayan may: (1) maintain existing offices not mentioned in subsection (a) and (b) hereof (mandatory and optional position); (2) create such other offices as may be necessary to carry out the purposes of the municipal government, or (3) consolidate the functions of any office with those of another in the interest of efficiency and economy;

- H. Ensure that policies, plans and programs for the promotion of welfare of persons with disabilities are funded by both the national and local government.
- I. Monitor fundraising activities being conducted for the benefit of persons with disabilities.
- J. Seek donations in cash or in kind from local or foreign donors to implement an approved work plan for persons with disabilities, in accordance with existing laws and regulations; and.
- K. Perform such other functions as maybe necessary for the promotion and protection of the welfare of persons with disabilities

Section 5. Repealing Clause.

All previous ordinances and issuances inconsistent with this Ordinance are deemed amended or repealed.

Section 6. Effectivity.

This Ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.

Passed and enacted by the Sangguniang Bayan in session assembled on **March 27, 2023**, Municipality of Julita, Province of Leyte, Philippines.



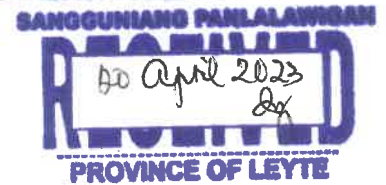
