



"AN ORDINANCE ADOPTING THE NEW OFFICIAL SEAL OF THE SANGGUNIANG BAYAN OF MAYORGA, PROVINCE OF LEYTE, PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL/UNAUTHORIZED USE THEREOF."

#### **EXPLANATORY NOTE**

WHEREAS, the Sangguniang Bayan of Mayorga recognizes the need for the council to have a logo/seal that will represent the principles and aspirations of the body;

WHEREAS, the Sangguniang Bayan is likewise necessary to identify official transactions and documents of the Sanggunian;


WHEREFORE, on motion by the Hon. Jairo C. Beltran duly seconded by the Hon. Mark Cloyd M. Tan-piengco; be it

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

**SECTION 1. TITLE.** 

This ordinance shall also be known as the "NEW OFFICIAL SEAL ORDINANCE OF THE SANGGUNIANG BAYAN OF MAYORGA, LEYTE."

#### **SECTION 2. PURPOSE.**

The purpose of this ordinance is to provide identity for the Office of the Sangguniang Bayan of Mayorga through an official seal to authenticate its official transactions. It shall appear in all official documents of the Sangguniang Bayan and in circumstances where the Sanggunian permits the use thereof.

#### **SECTION 3. AUTHORITY.**

This Ordinance is enacted pursuant to the provisions of R.A. 7160 otherwise known as the Local Government Code of 1991 which mandates the LGU to adopt adequate measures to protect, safeguard and improve quality of life for every Mayorgueño by imposing appropriate penalty for acts that dishonor the identity of the Sanggunian.

#### SECTION 4. OFFICIAL SEAL.

The New Official Seal of the Office of the Sangguniang Bayan of Mayorga, Province of Leyte shall be as depicted below:




The New Official Seal of the Office of the Sangguniang Bayan of Mayorga, Province of Leyte displays the Philippine Flag as its background with sixteen (16) double-stars and the images of a gavel, scrolls and a quill pen.

**PHILIPPINE FLAG** – The Philippine Flag symbolizes the allegiance to the Republic of the Philippines;

**SIXTEEN DOUBLE-STARS** - represents the sixteen (16) barangays in the municipality.

**GAVEL** – symbolizes the idea of a fair distribution of law, with no influence of bias, privilege or corruption;

**SCROLLS AND QUILL PEN** - symbolizes the duty of the Sanggunian to enact measures for the benefit of the common good.



**GREEN CIRCLE ROPE** – The green color represents growth and harmony while the rope symbolizes close relationship and cooperation among the constituents.

#### SECTION 5. USAGE OF THE OFFICIAL SEAL.

Only the Sangguniang Bayan of Mayorga, its officials and employees shall have the authority to use the Official Seal for the following purposes:

- 5.1. As personality of the Sangguniang Bayan of Mayorga in all of its affairs whether internal or corporate affairs and within or outside of its territorial jurisdiction;
- 5.2. To authenticate all Sanggunian official and public documents and other administrative and executive issuances; and
- 5.3. As letter heading in all Sanggunian official communications or correspondence.


# SECTION 6. CUSTODIAN OF THE ORIGINAL LAYOUT OF THE SEAL.

The Secretary to the Sangguniang Bayan shall have the custody to the original layout of the official seal of the Sangguniang Bayan of Mayorga, Province of Leyte and shall also be responsible in registration and filing of the Official Seal to the National Historical Commission of the Philippines or any appropriate agencies.

# SECTION 7. PROHIBITED ACTS IN THE USE OF THE OFFICIAL SEAL.

The following acts are declared unlawful, prohibited and deemed punishable by this ordinance:

- 7.1. By any act or omission, mutilate, deface, defile, trample on, or cast contempt with the intention to dishonor or ridicule the Official Seal;
- 7.2. To display the Official Seal under any frame or picture of a person or profile picture of social medias, like Facebook and others, except for Sanggunian government official representations;
- 7.3. To display the Official Seal in a platform or stage during programs or activities not directly or indirectly hosted by the Sangguniang Bayan of Mayorga, unless upon the permission of the Sanggunian;
- 7.4. To add any word, figure, mark picture, design, drawings, advertisement, or imprint of any nature which causes or likely to cause degradation on the Official Seal;
- 7.5. To print, paint or attach representation of the Official Seal whether full or partial on t-shirts, handkerchief, fan or other articles of merchandise, except for Sanggunian official representations;
- 7.6. To use or display the Official Seal as part of seminar, conferences, research or any activity except when undertaken by the Sangguniang Bayan of Mayorga;



- 7.7. To use or display the Official Seal as part of any advertisement or infomercial except when undertaken by the Sangguniang Bayan of Mayorga;
- 7.8. To be used for commercial or business purposes, except upon the authority of the Sanggunian;
- 7.9. To be used by any organization or association whether for legitimate purpose, except when approved by the Sangguniang Bayan of Mayorga;
- 7.10. To use the Official Seal for unlawful purposes:
- 7.11. To use the Official Seal as personal seal of any government official; and
- 7.12. Any other circumstances of a similar in nature and analogous to those above-mentioned.

# SECTION 8. MODIFICATION IN THE DESIGN OF THE SANGGUNIANG BAYAN OFFICIAL SEAL.

The Official Seal, its symbols, including its colors shall not be modified, unless:

- 8.1. By enactment of an Ordinance modifying the same;
- 8.2. Any modification shall be made for in accordance with the vision of the Sanggunian and only once every ten (10) years.

# SECTION 9. DRY SEAL OF THE OFFICE OF THE SANGGUNIANG BAYAN OF MAYORGA.

There shall be an adopted official dry seal in authenticating or subscribing official and public documents or administrative and legislative issuances. The dry seal shall contain the official seal of the Sangguniang Bayan of Mayorga.

# SECTION 10. PROHIBITED ACTS IN THE USE OF THE DRY SEAL.

The following acts are declared unlawful, prohibited and deemed punishable by this ordinance:

- 10.1. Use by any office/s other than the Office of the Sangguniang Bayan;
- 10.2. Affix the dry seal on a paper unauthentic, unofficial and not a public document;
  - 10.3. Affix the dry seal on a document for unlawful purpose/s;
- 10.4. Affix the dry seal on a document done outside the office or office hour;
- 10.5. To use the dry seal as personal dry seal of any official; and
  - 10.6. Any other circumstance of a similar in nature and analogous to those abovementioned.

#### **SECTION 11. PENALTY CLAUSE**

Any person, natural or juridical who by acts or omission violates the prohibited acts stated above shall be punished through the imposition of the following fines and penalties:

Furthermore, the penalty under this Ordinance shall not prejudice the filing of a separate criminal, administrative or civil liability.

#### **SECTION 12. SEPARABILITY CLAUSE**

If for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or otherwise invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

#### **SECTION 13. APPLICABILITY CLAUSE**

All other matters related to the impositions of this ordinance shall governed by the pertinent provisions of existing laws and other ordinances.

#### SECTION 14. REPEALING CLAUSE

All Ordinances Rules and Regulations, or parts thereof, in conflict with, or inconsistent with any provisions of this ordinance are hereby repealed and modified accordingly.

#### SECTION 15. EFFECTIVELY CLAUSE

This Ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Leyte.
