RESOLVED AS IT IS HEREBY RESOLVED, to ENACT the herein ORDINANCE:

MUNICIPAL ORDINANCE NO. 2023-05

AN ORDINANCE CREATING THE MUNICIPAL TOURISM OFFICE (MTO) OF THE MUNICIPALITY OF JULITA, LEYTE.

WHEREAS, consistent with local autonomy and decentralization as mandated under RA No. 7160 also known as the Local Government Code of 1991, Local Government Units shall endeavor to be self-reliant and shall exercise such powers and discharge such other functions and responsibilities for the provision of basic services and facilities;

WHEREAS, Section 76 of the Local Government Code of 1991 provides that, "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribe by the Civil Service Commission;

WHEREAS, Section 443 © of the Local Government Code likewise provides that "The Sangguniang Bayan may: (1) maintain existing offices not mentioned in subsection (a) and (b) hereof (mandatory and optional position); (2) create such other offices as may be necessary to carry out the purposes of the municipal government, or (3) consolidate the functions of any office with those of another in the interest of efficiency and economy;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Julita, Leyte in session assembled that:

Section 1. Title

This shall be known as an Ordinance Creating the Municipal Tourism Office (MTO) of the Municipality of Julita, Leyte.

Section 2. Creation of the Municipal Tourism Office (MTO).

The Municipal Tourism Office (MTO) is hereby created as one of the line function office of the Local Government Unit of Julita, Leyte.

Section 3. Functions of the MTO

- A. Promote tourism activities.
- B. Formulate programs and projects for the development of the local community as tourist attractions.
- C. Develop innate talents related to cultural, sports and economic endeavors through presentation and competitions.
- D. Develop new products, assist marketing and promoting the products and potential areas for tourist attraction and destination.
- E. Assist the Municipal Tourism Council in formulating programs and implement recommendations.
- F. Prepare annual budget for tourism promotion activities, allocate festival assistance fund in the municipality.
- G. Develop local tourism destination and attractions tapping local resources and national funds.
- H. Assist in the implementation of the Local Government Code on the matter of taxing and licensing of tourism related establishment in the locality, monitor and inspect to ascertain safe and enjoyable stay of travelers.

Section 4. Repealing Clause.

All previous ordinances and issuances inconsistent with this Ordinance are deemed amended or repealed.

Section 5. Effectivity.

This Ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.

Passed and enacted by the Sangguniang Bayan in session assembled on **March 27, 2023**, Municipality of Julita, Province of Leyte, Philippines.
