


## **CERTIFICATION OF POSTING**

**MUNICIPAL ORDINANCE NO. 152** 

(Proposed Municipal Ordinance No. 161)

AN ORDINANCE PROHIBITING LENDING INSTITUTIONS FROM ACCEPTING CASH CARDS, AUTOMATED TELLER MACHINE (ATM) CARDS, UCT AS COLLATERAL FROM BENEFICIARIES OF 4PS, SENIOR CITIZENS SOCIAL PENSION AND ALL OTHER SOCIAL PENSION PROGRAMS OF THE GOVERNMENT.

Be it ordained by the Sangguniang Bayan of Matag-ob, Leyte in regular session assembled, that:

Section 1. Short Title. This ordinance shall be known as the anti-Cash Card collateralization ordinance of Matag-ob, Leyte.

Section 2. Objective. This ordinance is intended to provide security to our social pensioners and 4Ps beneficiaries from the clutches of loan sharks and other lending institutions that usually charge exorbitant interest rates.

Section 3. Definition of Terms. The following terms, when used in the implementation of this ordinance shall mean as follows:

- a. Lending Institutions any bank, savings and loan association, insurance company or other organization or person regularly engaged in the business of lending money, guaranteeing loans for profit.
- b. Loan Sharks a money lender who charges extremely high rates of interest, typically under illegal conditions
  - c. ATM Card/Cash Card Automated Teller Machine Card
  - d. UCT Card Unconditional Cash Transfer Card
  - e. 4Ps Pantawid Pamilyang Pilipino Program

Section 4. Prohibition. Taking of ATM Card, Cash Card, UCT and the likes of social pensioners, 4Ps beneficiaries and the likes as collateral for loan payment is prohibited.

No person including but not limited to the pensioner himself to use his/her cash card for any social pension program as collateral for loans.

Section 5. Penalty Clause. Any person natural or juridical, found violating any provision of this ordinance shall be penalized as follows:

First offense - fine of 1,000.00 Second offense - fine of 1,500.00

Third offense - fine of 2,500 or imprisonment of Ten (10) days or both such fine and imprisonment at the discretion of the court.

Section 6. Repealing Clause. Any ordinances inconsistent herewith is hereby deemed or modified accordingly.

Section 7. Separability Clause. If any portion or provision of this Ordinance is declared invalid, unlawful, or unconstitutional, the remaining portions or provisions thereof, which are not affected thereby, shall remain in full force and effect.

Section 8. Effectivity. This Ordinance shall take effect fifteen (15) days after its posting and publication at any conspicuous places in the Local Government of Matag-ob, Leyte.
