

MUNICIPAL ORDINANCE NO. 156

(Proposed Municipal Ordinance No. 167)

AN ORDINANCE REGULATING THE USE AND OWNERSHIP OF CHAINSAW AND HANDSAW, IMPOSING FEES AND CHARGES THEREFOR AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Bayan of Matag-ob, Leyte in regular session assembled, that:

Section 1. Chainsaw and handsaw operation in the Municipality of Matag-ob, Leyte is hereby regulated.

Section 2. Policy. It is the policy of this administration to ensure full protection of its natural resources to make for a balance and sustainable ecology for the present and future generation. Toward this end, the Local Government shall pursue a thorough program to eliminate illegal logging and other forms of forest destruction through the use of chainsaws and handsaws, thus, the passage of this ordinance.

Section 3. Definition of Terms. The following terms used in this ordinance shall be taken as defined hereunder:

- a. Chainsaw any of the handy power saw that has teeth linked together to form an endless chain
- b. Chainsaw Operation the actual use of chainsaw either for commercial or personal purpose in converting logs, trees, coconuts or timber into lumber/cocolumber.
- c. Manual Handsaw a tool locally as known "mano-mano" used to slice logs into lumber fletches, including but not limited to single operated handsaw.
- d. MENRO Municipal Environment and Natural Resources Office

. Owners of chainsaw and handsaw either for commercial or personal purpose are required to register their chainsaw and handsaw before the Municipal Environment and Natural Resources Office every January of the fiscal year. The MENRO, having deemed the applicants as qualified operators shall correspondingly recommend for the issuance of a certificate of registration thereof. shall however not to be taken as alternative to the Registration issuance of permit by the DENR per RA 9175. mandatory

Applicants shall present the following documents to the MENRO upon accomplishing the prescribed registration form, viz.:

For Chainsaw:

- 1. Duly filled up application form (Form 1)
- 2. Official Receipt as proof of ownership
- 3. DENR Issued Permit
- 4. Stencil Serial Number of Chainsaw
- 5. Barangay Certification
- 6. A municipal registration fee of Php 400.00 for every chainsaw to be registered.

For Handsaw:

- 1. Duly filled up application form (Form 1)
- 2. Barangay certificate/or clearance which states clearly that the applicant is the actual owner of the unit and is resident of the barangay or have been residing in the barangay for at least six (6) months.

A registration fee of Php 100.00 for every handsaw to be registered. allowed to cut trees within the territorial jurisdiction of the municipality.

Section 6. Chainsaw Operation and Nuisance Affecting Public Peace. Operation of chainsaw within school and institutional zones shall be prohibited during class and office hours. In residential areas, chainsaw operation may only be permitted from 9 o'clock in the morning until 11:30 in the morning and to resume at 2:30 until 4:30 in the afternoon.

Exemption may be allowed only in times of emergency or calamity.

Section 7. Penalty. Violation of the provisions of this ordinance shall be punishable with the following fines:

First Offense – Fine of Php. 500.00 Second Offense - Fine of Php. 1,000.00

Third Offense - Php. 2,500.00 and revocation of Certificate of Registration.

8. Ordinance Officers. The MENRO, the Matag-ob PNP and all the Punong Barangays and their respective tanods are hereby designated as ordinance officers to prosecute the provisions of this ordinance.

Section 9. Separability Clause. In event or for any reason/s, any part/s, sections/s or provision/s of this Ordinance shall be held or declared be unconstitutional or invalid, the remaining part/s thereof which are not affected thereby, shall continue to be effective and in full force.

Section 10. Repealing Clause. Municipal Ordinance No. 06-39 series 2006, and any other ordinances, rules or policies which runs in conflict with the provisions of this ordinance is hereby deemed repealed or amended accordingly.

Section 11. Effectivity. This Ordinance shall take effect fifteen (15) days after its posting and publication at any conspicuous places in the Local Government of Matag-ob, Leyte.
