## MUNICIPAL ORDINANCE NO. 27, S-2023-2025

## AN ORDINANCE CREATING A PLANTILLA POSITION OF NURSE I, SALARY GRADE 15, IN THE MUNICIPALITY OF VILLABA AND PROVIDING FUND THEREOF

FUNDAMENTAL PRINCIPLES<br>Introduced by: HON. ROGELIO J. BAAY<br>Sangguniang Bayan Member

As a legislative body of the municipality, the sangguniang bayan is hereby mandated under Section 447, (a) of R.A. 7160 to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code.

The sangguniang bayan, through Section 443, (c), (2) of the same Republic Act or Local Government Code of 1991, may create other offices as may be necessary to carry out the objectives of the municipal government.

In reference to the above-stated principles,
BE IT ORDAINED, as the Sangguniang Bayan in regular session assembled hereby ORDAINED, that:

Section 1. Title. - This ordinance shall be known as "An Ordinance Creating a Plantilla Position of Nurse I, Salary Grade 15, in the Municipality of Villaba, Leyte, and Providing Fund Thereof."

Section 2. Legal Basis. - Authorizing the creation of the aforementioned plantilla position is Section 443, (a), (2) of the Local Government Code.

Section 3. Source of Fund. - There shall be set apart an appropriation amounting to four hundred twenty-one thousand, one hundred sixty-four pesos (Php 421,164.00) as annual salary for the plantilla position of Nurse I, Salary Grade 15 which shall be obtained from the MOOE in the Office of the Municipal Health Physician.

Section 4. Utilizing of Fund. - The above amount of four hundred twenty-one thousand, one hundred sixty-four pesos (Php 421,164.00) annual salary shall provide for the basic pay of thirty-five thousand, ninety-seven pesos (Php 35,097.00) of the Nurse I position in the LGU subject, however, to the availability of funds.


Section '5. Qualification Standards. - The qualification standards for the position of Nurse I, Salary Grade 15 are the following, to wit:
a) Education

- Bachelor of Science in Nursing
b) Experience
- None required
c) Training
- None required
d) Eligibility
- R.A. 1080

Section 6. Separability Clause. - If for any reason, any section or provision of this ordinance is declared unconstitutional or invalid, the other sections or provisions hereof which are not affected shall continue to be in full force and effect.

Section 7. Repealing Clause. - All ordinances, rules and regulations and other local issuances inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 8. Effectivity. - This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places pursuant to the posting requirement of the Local Government Code.

On motion for approval by the Hon. Rogelio J. Baay, SB Member, duly seconded en masse, this ordinance was approved.

This Ordinance was approved by the Sangguniang Bayan on March 13, 2023.
