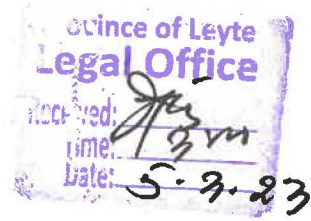

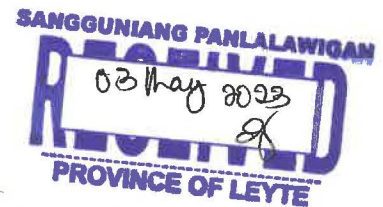



MUNICIPAL ORDINANCE NO. 28 ,S- 2023-2025

AN ORDINANCE CREATING A PLANTILLA POSITION OF MIDWIFE I, SALARY GRADE 9, IN THE MUNICIPALITY OF VILLABA AND PROVIDING FUND THEREOF

PREFATORY STATEMENTS
Introduced by: HON. ROGELIO J. BAAY
Sangguniang Bayan Member

In Section 447, (a) of the Local Government Code of 1991 (R.A. 7160), it is declared that "The sangguniang bayan, as a legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code."

Per Section 443, (c), (2) of the same R.A. 7160, "The sangguniang bayan may create other offices as may be necessary to carry out the purposes of the municipal government.

In consideration of the foregoing facts,

BE IT ORDAINED, as the Sangguniang Bayan in regular session assembled
Hereby **ORDAINED**, that:

Section 1. Title. – This ordinance shall be known as "An ordinance Creating a Plantilla Position of Midwife I, Salary Grade 9, in the municipality of Villaba and Providing Fund Thereof."

Section 2. LEGAL BASIS. – Giving authority to create the mentioned before plantilla position is Section 443, (a), (2) of the Local Government Code.

Section 3. Source of Fund. – There shall be set aside an amount of two hundred forty – four thousand, eight hundred twenty-four pesos (Php 244,824.00) per annum as yearly salary for the plantilla position of Midwife I, Salary Grade 9, which shall be derived from the MOOE of the Municipal Health Physician in the Annual Budget of the Municipality.

Section 4. Utilization of Fund. – The above amount of two hundred forty ^{four} thousand, eight hundred twenty-four pesos (Php 244, 824.00) shall be put to use to ^{my} provide for the monthly compensation of twenty thousand, four hundred two pesos (Php 20,402.00) for the new Midwife I position in LGU-Villaba.

Section 6. Separability Clause. – If for any reason, any section or provision of this ordinance is declared unconstitutional or invalid, the other sections or provisions hereof which are not affected shall continue to be in full force and effect.

Section 7. Repealing Clause. – All ordinances, rules and regulations and other local issuances inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.


Section 8. Effectivity. – This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places pursuant to the posting requirement of the Local Government Code.


On motion for approval by the Hon. Rogelio J. Baay, SB Member, duly seconded en masse, this ordinance was approved.
