

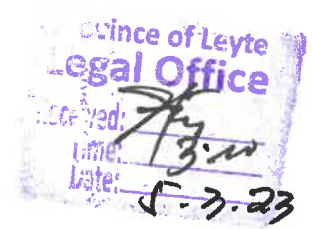

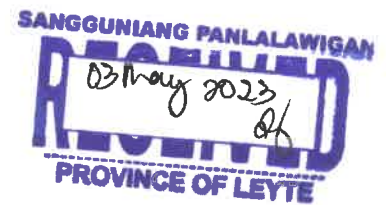

**MUNICIPAL ORDINANCE NO. 29, S-2023-2025**

**AN ORDINANCE CREATING A PLANTILLA POSITION OF NURSE III, SALARY GRADE 17, IN THE MUNICIPALITY OF VILLABA AND PROVIDING FUND THEREOF**

**UNDERLYING PRINCIPLES**  
**Introduced by: HON. ROGELIO J. BAAY**  
**Sangguniang Bayan Member**

By virtue of Section 447, (a) of the Local Government Code of 1991 (R.A. 7160) the sangguniang bayan, as the legislative body of the municipality, is authorized to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code.

Through Section 443, (c), (2) of the same Code, the sangguniang bayan may create other offices as may be necessary to carry out the objectives of the municipal government.

Taking into account the foregoing principles,


BE IT DECREED, as the Sangguniang Bayan in regular session assembled hereby DECREED, that:

**Section 1. Title.** – This documentary record shall be named as “An Ordinance Creating a Plantilla Position of Nurse III, Salary Grade 17, in the Municipality of Villaba and Providing Fund Thereof.”


**Section 2. Legal Basis.** – Giving lawful power to create the subject plantilla position is Section 443, (a), (2) of the Local Government Code.


**Section 3. Source of Fund.** – There shall be allocated an amount of four hundred ninety-eight thousand, ninety-six pesos (Php 498,096.00) per annum as salary for the plantilla position of Nurse III, Salary Grade 17, which shall be taken from the MOOE in the Office of the Municipal Health Physician.


**Section 4. Utilization of Fund.** – The Amount of four hundred ninety-eight thousand, ninety-six pesos (Php 498,096.00) annual salary shall support the monthly compensation of forty-one thousand, five hundred eight pesos (Php 41,508.00) of the Nurse III position in the LGU which shall, however, be subject to the availability of funds.



**Section 5. Qualification Standards.** – The QS for the position of Nurse III, Salary Grade 17, shall be as follows:

- |                |   |                                |
|----------------|---|--------------------------------|
| a) Education   | - | Bachelor of Science in Nursing |
| b) Experience  | - | 1 year of relevant experience  |
| c) Training    | - | 4 hours of relevant training   |
| d) Eligibility | - | R.A. 1080                      |

**Section 6. Separability Clause.** – If for any reason, any section or provision of this ordinance is declared unconstitutional or invalid, the other sections or provisions hereof which are not affected shall continue to be in full force and effect.

**Section 7. Repealing Clause.** – All ordinances, rules and regulations and other local issuances inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**Section 8. Effectivity.** – This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places pursuant to the posting requirement of the Local Government Code.


On motion for approval by the Hon. Rogelio J. Baay, Sangguniang Bayan member, duly seconded en masse, this ordinance was approved.
